Funding Provisions Annual Statement dated April 5, 2012

Section 18.4 of the Rocky Reach Settlement Agreement requires Chelan PUD, on an annual basis, to make available a statement indicating the status of all funding provided by Chelan PUD under the Proposed License articles, including the amount of funding provided and the amount of funding remaining available. The attached table provides a summary of funds available, stated in net present value, where applicable. The amounts have been adjusted to 2012 dollars using the CPI adjustment as of January 31, 2012 as outlined in Section 18.1 of the Settlement Agreement. The CPI adjustment for 2012 was 3.16%.

The measures that receive annual funding were calculated as follows: The unspent balance of annual payments to date was adjusted based on the 2012 CPI. The future year payments were adjusted based on the 2012 CPI and then calculated as one NPV value (based on a 2.5% interest rate and 7% discount rate) and added to the adjusted unspent balance to calculate the total remaining value of the measure.

Section 18.3 of the Settlement Agreement requires Chelan PUD to enter into payment agreements with the agencies prior to allocation of funds. Chelan PUD coordinated with the WDFW, BLM and USFS to obtain a 2012 annual work plan, including estimated funding amounts, as prescribed under Section 18.3 of the Settlement Agreement and in the payment agreements.
