Dear Secretary Bose:

On April 17, 2015, Mr. Jon Cofrancesco, Environmental Protection Specialist, Land Resources Branch, Division of Hydropower Administration and Compliance (DHAC), submitted a letter to the Public Utility District No. 1 of Chelan County (Chelan PUD) informing Chelan PUD of the Federal Energy Regulatory Commission (Commission) efforts to assist licensees in identifying, clearly, approved recreation facilities at their projects. In order to accomplish this task, the Commission is developing tables that reflect Commission approved recreation facilities and existing and pending recreation amenities at each recreation site at a project.

The intent of the letter was to address recreation facilities and as-built site plan drawing requirements for the Rocky Reach Hydroelectric Project (Project) (FERC No. 2145). The Project has an approved recreation plan and Entiatqua Trail implementation plan that requires Chelan PUD to file as-built drawings of the approved recreation facilities. The Commission orders approving the Project's recreation and trail implementation plans required filing as-built drawings within 60 days of completion of construction of the approved facilities. However, Commission staff was working collaboratively with Chelan PUD staff to develop and complete recreation tables for the Project, and, therefore, suspended the as-built site plan drawing requirements for the Project's recreation sites until completion of the tables.

As a result of the collaborative effort with Commission staff, Chelan PUD hereby files the accompanying facilities and amenities tables for the Project for Commission approval. For satisfying the requirement of developing a schedule for submitting as-built site plan drawings, Chelan PUD proposes to file with the Commission as-built site plan drawings specifically for

Entiat Park and Entiatqua Trail (to be combined into one single-line drawing) within 30 days of the date of the Commission's pending order.
