Re: **Lake Chelan Hydroelectric Project No. 637 (Project)  
License Article 410 and Appendix A, Agreement Article 10 – Lake Chelan Historic  
Properties Management Plan, Revised, November 2017**

Dear Secretary Bose:

Article 410 of the Project license<sup>1</sup> requires the Public Utility District No. 1 of Chelan County, Washington (Chelan PUD) to implement the Programmatic Agreement (PA)<sup>2</sup> and the revised Historic Properties Management Plan (HPMP).<sup>3</sup> In addition, Chelan PUD is subject to the provisions of Settlement Agreement Article 10 with regard to cultural resources at the Project.

FERC Order Approving Revised HPMP (issued April 25, 2013) and Section 5 of the HPMP, require Chelan PUD to review and revise the HPMP every five years.

On March 23 and November 2, 2017, Chelan PUD requested comments from the Lake Chelan Cultural Forum. The 2017 revisions include a more thorough discussion of the consultation process, the requirement to update the National Register of Historic Places Registration Form for the Lake Chelan Hydroelectric Power Plant, and the development of a maintenance plan for historic resources. Appendix H of the HPMP contains the Traditional Cultural Properties Management Plan (TCPMP). Appendix B, page 28 of the TCPMP was amended to change ownership of TCP-LC 52 from National Park Service to Forest Service. Please see Attachment B to view the consultation summary table and documentation.

Chelan PUD respectfully requests that the Federal Energy Regulatory Commission (Commission) approve this 2017 HPMP as included in Attachment A.
