Subject: Rocky Reach Hydroelectric Project, FERC No. 2145
Article 404 – Ute Ladies’-Tresses (*Spiranthes diluvialis*) Discovery Report

Dear Secretary Bose and Deputy Secretary Davis:

The Federal Energy Regulatory Commission (Commission) issued the “Order on Offer of Settlement and Issuing New License” (License) for the Rocky Reach Hydroelectric Project No. 2145 (Project) on February 19, 2009. In accordance with License Article 404, the Public Utility District No. 1 of Chelan County (Chelan PUD) is required to file a report within 90 days of discovering a new population of a Ute Ladies’-Tresses with the Commission.

Chelan PUD hereby files the report describing the population size, any identified threats to the newly discovered population, and any recommendations for modifying the Ute Ladies’-tresses Management Plan to include additional protection measures or to modify the monitoring and survey efforts to address the new population. The report was prepared after consultation with U.S. Fish and Wildlife Service (FWS), Bureau of Land Management (BLM), and Washington Department of Fish and Wildlife (WDFW).


In September 2009, a total of 43 Ute Ladies’ Tresses plants were documented at two new locations, including 42 plants on WDFW land and one on Chelan PUD land. The detailed description, numbers and locations of these new plant discoveries are provided in the September 24 and 28, 2009, notification emails and September 30, 2009, formal notification letter (see **Attachment A**¹). Within ten days of discovery, Chelan PUD sent the emails to Erich Gaedeke (Commission), Gregg Kurz (FWS), Ron Fox (WDFW), Pam Camp (BLM) and Julie Sanderson (BLM) and, Karen Kelleher (BLM). Chelan PUD followed up with a formal notification letter to the same agencies.

¹ **Attachment A contains federally-threatened plant sites and meets the privilege treatment requirements under 18 CFR 388.112(c). In order to protect this sensitive information, Chelan PUD requests the Commission not to release the enclosures to the general public. However, the cover letter can be released to the public.**

Threats to new populations will be considered annually by the Rocky Reach Wildlife Forum (RRWF), as described in the modified Ute Ladies' Tresses Management Plan (Plan) dated December 15, 2009 (see Attachment B). The Plan provides the protection measures and monitoring and survey efforts to address the new populations. Consultation records are included as Attachment C.
