The Federal Energy Regulatory Commission (Commission or FERC) issued the “Order on Offer of Settlement and Issuing New License” (License) and “Order on Rehearing and Clarification” for the Rocky Reach Hydroelectric Project No. 2145 (Project) on February 19, 2009, and May 21, 2009, respectively. In accordance with License Article 405, the Public Utility District No. 1 of Chelan County, Washington (Chelan PUD or Licensee), is required to file a report within 30 days of every anniversary of the date of issuance of the License.

Chelan PUD hereby files its first annual report with the Commission in fulfillment of the Rocky Reach Historic Properties and Cultural Resources Management Plan (HPCRMP) (February 3, 2006) and the Programmatic Agreement for the Project. This report includes activities conducted under the implemented HPCRMP for calendar year 2009.

Additional copies will be filed by copy of this letter with the Washington State Historic Preservation Office, the Confederated Tribes of the Colville Reservation Tribal Historic Preservation Officer, USDA Forest Service, Bureau of Land Management, the Confederated Tribes and Bands of the Yakama Nation and the Bureau of Indian Affairs.
