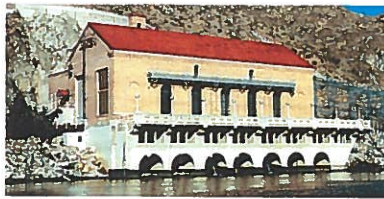

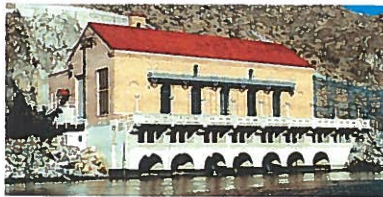
As Chelan PUD's Project Engineer/Manager responsible for design and quality control of the subject project, I hereby certify the following:
