Subject: Overview Site Plan Drawing and As-built Drawings for Entiat Park, Entiatqua Trail, and Daroga State Park

Dear Mr. Osborn:

On October 21 and November 30, 2016, you filed an overview site plan drawing and as-built drawings for the Entiat Park, Entiatqua Trail, and Daroga State Park recreation sites for the Rocky Reach Hydroelectric Project, FERC No. 2145.

By order issued October 12, 2010, Commission staff approved, with modification, your recreation management plan for the project.<sup>1</sup> Ordering paragraph (D) of the order requires you to file as-built drawings within 60 days of completion of specific recreation sites identified in the plan, including Entiat Park, Entiatqua Trail, and Daroga State Park. By letter issued April 15, 2015, Commission staff suspended the as-built drawing filing requirement until you finalized recreation tables summarizing the required recreation facilities and amenities at recreation sites identified in the plan. Subsequently, you completed these recreation tables and by letter issued September 23, 2016, Commission staff accepted your recreation tables and your planned schedule for filing the required as-built drawings, as well as, an overview site plan drawing.

Based on our review, we find that your overview site plan drawing adequately identifies project recreation sites and includes the accepted recreation facilities table. Further, your as-built drawings of the above recreation sites adequately show the type and

location of recreation facilities at each site in relation to the project boundary.<sup>2</sup> For these reasons, we find that the drawings satisfy the requirements of ordering paragraph (D) of the October 12, 2010 order. No further Commission action will be taken on your filings.

<sup>2</sup> During our review, we found that the as-built drawings for Entiat Park and Entiatqua Trail respectively, did not clearly identify the required informal swim beach, all the required picnic tables and day-use parking spaces, or the required bench along Entiatqua Trail. By e-mail dated March 31, 2017, your staff confirmed the presence of and location of these facilities on the drawings of each site. This supplemental information provides the necessary missing information, which also corresponds with the information in the recreation facilities table included on the overview site plan drawing.
