A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO ENTER INTO A CONTRACT (CONTRACT NO. 17-50) WITH HARRIS CORPORATION OF DELAWARE FOR THE PURCHASE, INSTALLATION, AND SUPPORT OF THE DIGITAL MOBILE RADIO SYSTEM

FACTUAL BACKGROUND AND REASONS FOR ACTION

District staff has identified the need to replace the legacy Land Mobile Radio system. The radio system provides critical two-way radio communications for District crews performing work within the hydro facilities and throughout Chelan County. Proposals were solicited from qualified firms with Request for Proposal No. 17-50 (RFP) to supply, install, and support a new Digital Mobile Radio system. The RFP process allowed the District to evaluate proposals based on qualitative criteria in addition to price assuring the best solution with the greatest benefit for the District and our customer-owners. Resolution No. 17-14215 requires that the Commission, by resolution, authorize contracts that exceed \$3,000,000.

Harris Corporation of Delaware has prepared a proposal to supply and install a new Digital Mobile Radio System in the amount of \$3,851,763 and provide 10 years of support for an additional \$1,142,551, for a total amount of \$4,994,314. The proposal has been negotiated pursuant to RCW 39.04.270 and Resolution No. 17-14215.

District staff has determined that Harris Corporation is the best qualified firm to provide the required services and that the cost for said services of \$4,994,314 is a fair and reasonable price.

It is District staff's recommendation that it is in the best interest of the District to enter into a contract with Harris Corporation for the above-described services. District staff also recommends including construction contingency in the amount of \$192,588, or 5% of the purchase amount, for a total not-to-exceed authorization of \$5,186,902.

The General Manager of the District has reviewed staff's recommendation and concurs in the same.

ACTION

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, as follows:

Section 1. The General Manager of the District is hereby authorized to enter into a contract with Harris Corporation for the purchase, installation, on-going support, and

contingency for the Digital Mobile Radio System in an amount not to exceed \$5,186,902 without prior Commission approval. A copy of the Agreement is on file in the offices of the District.
