A RESOLUTION DELEGATING TO THE GENERAL MANAGER THE AUTHORITY TO ADJUST FEES AND CHARGES IN RELATION TO INCREASING OR DECREASING UNDERLYING COSTS

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District, in compliance with RCW 54.24.080, is required to establish, maintain, and collect rates or charges for electric energy and water and other services, facilities, and commodities sold, furnished, or supplied by the district. The rates and charges shall be fair, nondiscriminatory, and shall be adequate to provide revenues sufficient for the payment of the principal of and interest on such revenue obligations for which the payment has not otherwise been provided and all payments which the district is obligated to set aside in any special fund or funds created for such purpose, and for the proper operation and maintenance of the public utility and all necessary repairs, replacements, and renewals thereof.

The District collects certain fees and charges as part of its utility operations. The fees and charges are defined generally as a one-time fee or charge based on recovering the costs for providing that service. The attached Exhibit A provides a listing of current fees and charges. Utilizing sound and reasonable business practices, utility service fees and charges are designed to provide a fair and consistent method for providing services while adequately recovering costs. As new business or utility practices are developed and/or costs change, the District should adjust the appropriate fees and charges accordingly. Currently these existing fees and charges are embedded in existing rate schedules or service regulations and it is difficult to adjust and update those fees and charges in a timely manner.

The District regularly has the need to adjust cost based fees and charges. The District's Commission has the authority to delegate its administrative powers and duties provided guidelines and procedures are established. District staff recommends that it is in the best interest of the District to delegate authority to the General Manager to take actions necessary with respect to listed fees and charges and any new cost recovery fees and charges. This delegation provides the flexibility needed to do business effectively and efficiently.

Specifically, staff recommends that the General Manager analyze and project cost adjustments or new fees and charges during the District's annual budget cycle. Further, the General Manager should be able to adjust, change or add fees and charges as needed during a calendar year to ensure full cost recovery.

The General Manager has reviewed staff's recommendation and concurs in the same.

ACTION

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, WASHINGTON, as follows:

Section 1. The Commission finds it is in the District's best interests to delegate to the General Manager or his designee the authority to adjust the fees and charges listed on Exhibit A or add fees and charges when necessary to recover District costs. Prior to doing so, the General Manager will only act according to the following procedures:

- a. An analysis shall be prepared that identifies existing or forecasted changes in costs and/or their drivers.
- b. The General Manager or designee will discuss the revised fees and charges and the analysis with the District's Commission during an informational or budget presentation at a regularly scheduled Commission meeting.
- c. Discussion with the Commission will occur prior to any changes being finalized.

BACKGROUND

The following policy section identifies District polices that are subject to changes by the General Manager of Chelan County Public Utility District. Per resolution 07-XXXX, dated September XX, 2007, the Board of Commissioners has authorized the General Manager to Establish and administer the Electric, Water, Wastewater and Network Line Extension Fees and Charges. In addition, this section identifies other one-time service fees that the General Manager may adjust as costs and application methods change

Utilizing sound and reasonable business practices, all Utility line extension policies and service fees are designed to provide a fair and consistent method for providing utility services while adequately recovering costs. As new methods are developed and costs change the District will adjust the line extension policies and service fees to reflect that. Normal practice will be to analyze and project any cost adjustments during the District's annual budget cycle, however changes may be made on an as needed basis if needed.

Any proposed changes will be communicated to the Board of Commissioners during open session. In addition changes that may impact identified groups or stakeholders will be communicated at the earliest possible opportunity.

All other services in excess of 150ft shall be approved by engineering prior to install.

D. ELECTRICAL REQUIREMENTS

1. The customer shall pay all costs and fees in advance, including, but not limited to the cost of permits, easements, clearing and any other special costs to provide service. These costs and fees will be in addition to any line extension or other costs that may be required and are not reimbursable

- There shall be a fee for all overhead secondary services, which shall include up to 150 feet of conductor (wire). The measurement shall be from the transformer location. For conductor in excess of 150 feet, there shall be an additional fee charged on an actual cost basis
- 3. For underground facilities, the Residential Customers has the option to (1) provide District approved service conductor and have it installed by their licensed Electrical Contractor or, (2) have the District supply and install the service conductor, up to 150 feet, for the fee set forth below. For service conductor in excess of 150 feet, there shall be an additional fee charged on actual costs basis. For overhead and underground, the measurement shall be from the transformer location. All other customer classes will supply and install the secondary service conductor per District Electrical Service Requirements.
- 4. There shall be a transformer and meter fee for the (1) permanent service connections and (2) capacity additions to existing service. The fee will be determined by the ampacity rating of the meter base (and service equipment rating).
- 5. For unusual situations, the service connection shall be the actual costs of all transformers and metering the District installs. This fee will not apply to temporary service installations.
- 6. Service connection fees may be paid in cash or financed thought the District. Financing is available only for residential meter base installations up to 200 amps and total fees over \$600. The District shall charge interest on the amounts financed and a lien will be place on the property.
- 7. "Actual Cost" line extension as defined in the line extension policy will include an additional 5% administrative fee for auditing.
