## History and Purpose

- □ Public Utility Regulatory Policies Act (PURPA) of 1978
  - Conservation of energy supplied by electric utilities;
  - Optimal efficiency of electric utility facilities and resources; and
  - Equitable rates for electric consumers
- □ Originally six federal standards

## New PURPA Standards

- □ Four standards were added in 1992's Energy Policy Act
- □ Five standards were added in 2005's Energy Policy Act

Net metering	Addressed in 2006
Time-based metering and communications	Addressed in 2006
Interconnection	Addressed in 2006
Fuel diversity	Need to address
Fossil fuel generation efficiency	Need to address

## Energy Policy Act/PURPA Language

- □ Fuel Sources "Each electric utility shall develop a plan to minimize dependence on 1 fuel source and to ensure that the electric energy it sells to consumers is generated using a diverse range of fuels and technologies, including renewable technologies."
- □ Fossil Fuel Generation Efficiency "Each electric utility shall develop and implement a 10-year plan to increase the efficiency of its fossil fuel generation."

# Board action required

- □ PURPA requires electric utilities to "consider" each standard and then "make a determination" about whether or not it is appropriate to implement
  - Consideration and determination is required, but the decision to implement is discretionary
  - For public power utilities, the Board of Commissioners must "consider and determine" the standards

## Procedural Requirements

- Public notice and hearing
- □ Determination made in writing, based upon findings and evidence presented in a hearing (from staff or other parties)
- □ Determination on the record, made available to the public
- Hearing transcripts

# Schedule

July 30, 2007	Initial Board briefing on PURPA
August 5, 2007	Publish notice on 1) consideration of fuel diversity standard and 2) staff recommendation "not to adopt" (as not applicable) the fossil fuel efficiency standard. Request public comments or proposals
October 19, 2007	Publish notice of hearing
November 4, 2007	Publish advertisement of hearing
November 19, 2007	Hold hearing on fuel diversity standard and approve a resolution determining whether to adopt, not adopt or adopt in part Approve resolution not to adopt fossil fuel efficiency standard

## Preliminary Recommendations

- □ Fossil fuel efficiency standard
  - Not adopt as not applicable to the District
- □ Fuel diversity standard
  - Energy Resources will develop a recommendation for fuel diversity, based on staff input, written comments, and recent state initiatives and legislation

### Factors to Consider

- □ Renewable Portfolio Standard
- □ Integrated Resource Planning
  - Electric utilities required to develop IRPs by September 1, 2008
  - IRPs describe a utility's mix of generation, conservation and efficiency resources that will meet current and projected needs at the lowest reasonable cost to the utility and its ratepayers
