## **Rocky Reach Park Facilities Regulations**

## To Our Guests,

The Visitor Center, fourth floor gallery and the Museum of the Columbia at Rocky Reach Dam, together with the day-use facilities, are owned, operated and maintained by the District for general public use. We work hard to offer a comfortable, safe and enjoyable experience for all of our guests. You can help us by keeping in mind the following:

- All persons, bags, parcels and other items may be subject to security checks at the point of admission to the Visitor Center.
- All park users shall comply with state statutes with regard to the use, possession, transportation and discharge of any firearm or other weapon. The possession of weapons is NOT allowed beyond the metal detector at the Visitor Center.
- Please show common courtesy to fellow park guests and our employees. Do not use profanity or engage in unsafe, illegal or offensive behavior.
- Proper attire—including shoes and shirts—must be worn at all times when entering the Visitor Center and powerhouse.
- Backpacks are not allowed in the Visitor Center.
- Smoking is not allowed in the Visitor Center or powerhouse. Smoking is allowed in designated smoking areas only.
- Please supervise your children at all times. Children must be accompanied by an adult while in the Visitor Center, powerhouse and the Museum of the Columbia.
- Alcoholic beverages are not allowed.
- Only a pet that is small enough to be held at all times comfortably (with the exception of service animals) will be allowed in the Visitor Center and powerhouse. Pets must be leashed or otherwise restrained for their own safety as well as the safety of other users when in the park.
- Vehicle parking only is allowed in designated parking areas. **Vehicles are not allowed on the lawns at any time**. If you have any equipment that needs to be unloaded for a wedding or a function, please do not drive the vehicles onto the grass to unload.
- Plastic runners that are generally used for weddings are not allowed on the grass.
- Plastic swimming pools, "slip and slides" or inflatable bounce houses are not allowed on the lawns due to the damage that they cause to the grass.



- Cooking fires are prohibited on the grounds. Free standing barbecues or approved outdoor cooking devices are allowed in designated picnic sites.
- Do not dump food or grease down the drains in the shelter picnic areas.
- No camping allowed at any time.
- Users are responsible for repair and/or replacement of any District equipment lost, damaged or stolen, or facility damage as a direct result of the event.
- The hours for Rocky Reach Park and the Visitor Center vary throughout the season. If you are planning to have a wedding rehearsal at Rocky Reach the day prior to a wedding, please keep in mind the closing hours for this park.

We reserve the right to deny admission, or to require a person already admitted to leave the project, for failure to comply with any of the park rules, for unsafe, illegal or offensive behavior, to ensure safety, security or order, or if we consider that the circumstances so require.

We may from time to time, without prior notice, change the operating hours of the park or Visitor Center, close the park or any part of it temporarily, to ensure safety, security or order, or if we consider that the circumstances so require.

It is the policy of Chelan PUD that the PUD and all third-party groups using PUD parks and/or facilities will not discriminate against any person contrary to law in the use, operation, conduct or administration of the parks and/or facilities.
