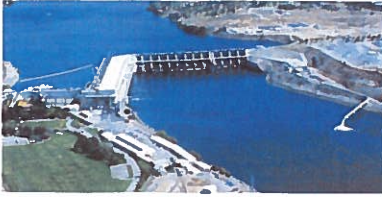
Dear Chelan River Fishery Forum: Please find the attached letter to the Federal Energy Regulatory Commission (FERC) regarding notification of temporary pumped flow change to the Chelan River Habitat Channel for fall 2017. As you are aware, Chelan PUD filed a letter on March 13, 2017 requesting to amend the minimum pumped spawning flow requirement to the Chelan River Habitat Channel, per direction from the Chelan River Fishery Forum (CRFF). Because the October 15 initiation of spawning flow for Chinook salmon is approaching, T.J. Lovullo, FERC Aquatic Resources Branch Chief, Washington, D.C. recommended that Chelan PUD file this notification letter until such time as the amendment process can be completed, which will be after October 15. Chelan PUD is continuing to work with Ecology to amend the 401 water quality certification for the Lake Chelan Project, and file that amended certification with FERC to complete the amendment process.

Change in Pumped Flow to Habitat Channel for Fall 2017**

Dear Secretary Bose:

Public Utility District No. 1 of Chelan County (Chelan PUD) hereby notifies the Federal Energy Regulatory Commission (Commission) of its intent to continue a temporary reduction in pumped flow to the Chelan River Habitat Channel by providing a minimum flow of 260 cfs rather than a minimum 320 cfs during the fall (October 15 through November 30, 2017) Chinook salmon spawning period. A previous notification letter regarding a temporary change in pumped flow was filed with the Commission on October 13, 2016.

On March 13, 2017, Chelan PUD filed with the Commission a request to amend the *Operations Compliance Monitoring Plan*, Section 2.1, Table 1¹; the *Threatened and Endangered Species Protection Plan*, Section 2.1, Table 1²; and license Appendix A, Settlement Agreement License Article 7(b)(1) to change the minimum pumped flow. As stated in that filing, Chelan PUD and the Chelan River Fishery Forum (CRFF)³ have found that a reduced flow improves spawning habitat for Chinook salmon and steelhead. Simultaneously, Chelan PUD filed an application with


³ The CRFF is comprised of the federal and state fishery agencies, Tribes, and local governments that are signatories to the Lake Chelan Comprehensive Settlement Agreement (SA) and assist Chelan PUD with implementing terms and conditions of the Lake Chelan Hydroelectric Project license associated with the Chelan River. The CRFF consists of the following entities: Washington Department of Fish and Wildlife, USDA Forest Service, National Park Service, NOAA Fisheries, U.S. Fish and Wildlife Service, Colville Confederated Tribes, Yakama Nation, Washington Department of Ecology, Chelan PUD, and city of Chelan.

the Washington State Department of Ecology (Ecology) to make the same change to the 401 Water Quality Certification for the Project ("Certification"), which filing is pending before Ecology. Chelan PUD will file the amended Certification with the Commission once received from Ecology.

Because Chelan PUD's application to amend minimum flows may still be pending during this fall's spawning period, Chelan PUD is following the recommendation from T.J. Lovullo, Aquatic Resources Branch Chief, in Washington D.C., to provide the Commission notification of a temporary change in pumped flow operations for fall 2017.
