Dear Secretary Bose and Deputy Secretary Davis:

In accordance with Article 301, *Revised Exhibits and As-built Drawings*, the Public Utility District No. 1 of Chelan, County, Washington (Chelan PUD) hereby files an original and five copies of the as-built drawing in electronic format for the Reach 1 Trail extension (formerly known as the Riverwalk Loop Trail Extension). Additionally, one copy will be submitted to the Federal Energy Regulatory Commission's (Commission) Division of Dam Safety and Inspections Portland Regional Engineer and one to the Director, Division of Hydropower Administration and Compliance by copy of this letter.

The Reach 1 Trail extension connects the existing Chelan Riverwalk Loop trail to the newly constructed Reach 1 Trail of the Chelan River. An as-built drawing for the completed Reach 1 Trail was filed with the Commission on March 2, 2009. Construction of the Reach 1 Trail extension started in 2009 and was completed in spring 2010. The trail extension has been added to the Reach 1 Trail as-built drawing. Therefore, please replace the as-built drawing sent previously with the attached updated as-built drawing of the Reach 1 Trail.

Pending your approval, please provide us with an assigned drawing number so that we may submit the aperture cards, electronic files, and location date points needed for the Commission's databases. This work did not affect the Exhibit G Project Boundary.
