A RESOLUTION RATIFYING FIELD WORK ORDER/CHANGE ORDER NO. 1, AUTHORIZING FINAL ACCEPTANCE OF WORK PERFORMED UNDER BID NO. 21-29 WITH SE, INC., DBA SMITH EXCAVATION OF CASHMERE, WASHINGTON FOR CONSTRUCTION OF TECHNOLOGY CENTER WAY EXTENSION AND AUTHORIZING RELEASE OF THE BOND IN LIEU OF RETAINAGE

### FACTUAL BACKGROUND AND REASONS FOR ACTION

The Commission, by Resolution No. 17-14215, delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less. Bids were received in accordance with RCW 54.04.070 and there was one bid in which the bidder took exception to the District's terms and conditions.

On August 22, 2022, the District entered into a contract (Bid No.21-29) with SE, Inc., dba Smith Excavation (Contractor) of Cashmere, Washington for Technology Center Way Extension, in the amount of \$719,100.00. This contract was advertised for public bid and was awarded as required by RCW 54.04.070 and .080.

The work in Field Work Order/Change Order No. 1 consists of conditions and work not anticipated or included in the original contract but within the scope of the contract. The District's staff has executed Field Work Order/Change Order No. 1, which is on file in the offices of the District and summarized as follows:

Field Work Order/Change Order No. 1 results in a net decrease in the contract price for a new revised total price of \$709,375.42 (excluding sales tax) and District staff recommend it be ratified. Resolution Nos. 17-14215 provides that this type of field work order/change order shall be presented to the Commission for approval as part of the final acceptance resolution.

District staff has determined that the completion of all contract work occurred on January 4, 2024. In accordance with the terms of the contract, the Contractor has provided a bond in lieu of retainage equal to 5% of the contract price.

The General Manager of the District concurs with staff's recommendations that the District accept the work performed by the Contractor, ratify Field Work

Order No. 1 and authorize the release of the related bond in lieu of retainage, subject to the requirements of the contract and state law.

### **ACTION**

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NOS. 1 OF CHELAN COUNTY, WASHINGTON, as follows:

<u>Section 1</u>. Field Work Order/Change Order No. 1 to Bid No. 21-29 with SE, Inc., dba Smith Excavation for the work specified above, which will result in a net decrease in the contract price of \$719,100, for a total revised contract price of \$709,375.42, plus Washington State sales tax, is hereby ratified.

Section 2. All the contract work required under Bid No. 21-29 was completed on January 4, 2024 and the same is hereby accepted, subject to Section 3 hereof. Release of the Contractor's bond in lieu of retainage is authorized subject to Section 3 and Section 4 hereof, and subject to the provisions and limitations of Chapter 39.12 RCW (Prevailing Wages on Public Works) and 60.28 (Liens for Labor, Materials and Taxes on Public Works).

Section 3. This resolution shall not constitute an acceptance by the District of any work performed or goods supplied pursuant to the aforementioned contract, which are not in strict compliance with the contract terms and conditions.

Section 4. After the expiration of the forty-five (45) day period for giving the District notice of lien and after receipt of the Department of Revenue's certification of the Contractor's payment of taxes, the Employment Security Department's Certificate of Payment of Contributions, Penalties and Interest on Public Works Contracts, and the Department of Labor & Industries' Certificate of Release of the State's Lien on Public Works Contracts and the District being satisfied that taxes certified as due or to become due are discharged and the filed claims of materialmen and laborers, if any, together with a sum sufficient to pay costs of foreclosing the liens and attorney's fees, have been paid, the District's General Manager is authorized and directed to release the bond in lieu of retainage. In the event said taxes, claims, expenses and fees have not been paid, the General Manager is authorized and directed to file a claim against the bond in lieu of retainage in an amount equal to unpaid taxes and unpaid claims, together with a sum sufficient to defray the costs and attorney fees incurred in foreclosing the lien of such claims, and following payment of such claim, release the bond in lieu of retainage.

RESOLUTION RATIFYING FIELD WORK ORDER/CHANGE ORDER NOS. 33-39 AND FURTHER APPROVING FIELD WORK ORDER/CHANGE ORDER NO. 40 FOR THE SERVICE CENTER PROJECT WITH ABSHER CONSTRUCTION COMPANY OF PUYALLUP, WA FOR CONSTRUCTION OF THE SERVICE CENTER **PROJECT PURSUANT** TO GENERAL CONTRACTOR/CONSTRUCTION **MANAGER** (GC/CM) CONTRACT NO. 18-91

### FACTUAL BACKGROUND AND REASONS FOR ACTION

On March 4, 2019, by Resolution No. 19-14327, the Commission of the District authorized the General Manager to invite sealed proposals to provide General Contractor Construction Manager (GC/CM) services to the District in support of the planned Service Center Project.

On April 15, 2019, by Resolution No. 19-14334, the Commission of the District approved the Service Center Project and adopted the project capital budget.

On July 1, 2019, by Resolution No. 19-14356, the Commission of the District authorized the General Manager to enter into Service Center Contract No. 18-91 with Absher Construction Company. In addition to the general terms and conditions, the Contract authorized \$500,000 for preconstruction services.

On August 3, 2020, by Resolution No. 20-14477, the Commission of the District authorized the General Manager to enter into Guaranteed Maximum Price (GMP) Amendment No. 1 to Contract No. 18-91 with Absher Construction Company for site work construction in the amount of \$8,960,518, for a total revised contract amount of \$9,460,518, excluding sales tax.

On February 1, 2021, by Resolution No. 21-14524, the Commission of the District authorized the General Manager to enter into GMP Amendment No. 2 for construction of the Service Center in the amount of \$95,132,983, in addition to ratifying Field Work Order/Change Order Nos. 1-2 in the amount of \$206,005, for a total revised contract amount of \$104,799,506, excluding sales tax.

On July 19, 2021, by Resolution 21-14576, the Commission of the District ratified Field Work Order/Change Order Nos. 3-6 for construction of the Service Center in the amount of \$343,619, for a total revised contract amount of \$105,143,125, excluding sales tax. In addition, Resolution 21-14576 authorized the General Manager to execute Field Work Order/Change Orders (FWO/CO) up to a cumulative value of

\$1,000,000 and further authorized the General Manager to re-delegate project specific authority pursuant to Section 8 of Attachment No. 1 of Resolution 17-14215.

On June 6, 2022, by Resolution 22-14667, the Commission of the District ratified Field Work Order/Change Order Nos. 7-12 for construction of the Service Center in the amount of \$821,355, for a total revised contract amount of \$105,964,480, excluding sales tax.

On November 7, 2022, by Resolution 22-14709, the Commission of the District ratified Field Work Order/Change Order Nos. 13-17 for construction of the Service Center in the amount of \$930,729 for a total revised contract amount of \$106,895,209, excluding sales tax.

On February 21, 2023, by Resolution 23-14739, the Commission of the District ratified Field Work Order/Change Order Nos. 18-21 and further approved Field Work Order/Change Order No. 22 for construction of the Service Center in the amount of \$2,945,587 for a total revised contract amount of \$109,840,796, excluding sales tax.

On March 20, 2023, by Resolution 23-14747, the Commission of the District ratified Field Work Order/Change Order No. 23 and further approved Field Work Order/Change Order No. 24 for construction of the Service Center in the amount of \$5,232,532 for a total revised contract amount of \$115,073,328, excluding sales tax.

On April 17, 2023, by Resolution 23-14756, the Commission of the District ratified Field Work Order/Change Order No. 25 and further approved Field Work Order/Change Order No. 26 for construction of the Service Center in the amount of \$4,208,386 for a total revised contract amount of \$119,281,714, excluding sales tax.

On June 26, 2023, by Resolution 23-14779, the Commission of the District ratified Field Work Order/Change Order Nos. 27-29 and further approved Field Work Order/Change Order No. 30 for construction of the Service Center in the amount of \$2,176,333 for a total revised contract amount of \$121,458,047, excluding sales tax.

On August 7, 2023, by Resolution 23-14792, the Commission of the District ratified Field Work Order/Change Order No. 31 and further approved Field Work Order/Change Order No. 32 for construction of the Service Center in the amount of \$1,690,433 for a total revised contract amount of \$123,148,480, excluding sales tax.

The District Commission by Resolution Nos. 17-14215 and 21-14576 delegated limited authority to the General Manager and the staff to execute field work orders/change orders under certain circumstances.

The work in Field Work Order/Change Order Nos. 33-39 consist of conditions and work not anticipated or included in the original contract but within the scope of the contract. The District's staff has executed Field Work Order/Change Order Nos. 33-39, which are on file in the offices of the District and summarized as follows:

Field Work Order/Change Order Nos. 33-39 result in a net increase in the contract price of \$965,541 for a revised total price of \$124,114,021, (excluding sales tax), which the District's Engineers recommend be ratified.

Additionally, District Staff recommends execution of Field Work Order/Change Order No. 40 to increase the contract price by \$527,718 for a revised total price of \$124,641,739 (excluding sales tax). Field Work Order/Change Order No. 40 increases Contractor Contingency funding associated with the cultural delay, and includes cost for 2023 asphalt pricing and grading revisions to utilize surplus soils.

The General Manager of the District concurs with staff's recommendation that Field Work Order/Change Order Nos. 33-39 be ratified and further approve Field Work Order/Change Order No. 40.

A RESOLUTION AUTHORIZING AMENDMENT NO. 5 TO SERVICES AGREEMENT (SA-TA NO. 21-11370) WITH GREENWORKS, P.C. FOR RIVERFRONT PARK ENHANCEMENTS

### FACTUAL BACKGROUND AND REASONS FOR ACTION

After an extensive community planning effort, the Riverfront Park Development Plan was approved by the District Board of Commissioners and the Wenatchee City Council on December 6, 2021 and January 13, 2022 respectively. Wenatchee Riverfront Park is a defining feature of the community and the most urban segment of the Apple Capital Loop Trail. The park includes approximately 31 acres and a majority of the land in the park is owned by the City of Wenatchee (City) and has been leased to the District since 1983 to support park development as part of the District's responsibilities under its federal license for the Rock Island Project (FERC Project #943).

The District entered into a Services Agreement (SA-TA No. 21-11370) on March 18, 2021, with GreenWorks, P.C. to provide professional services associated with Riverfront Park Enhancements in an amount not to exceed \$400,000. Subsequently, Amendment Nos. 1 and 3 were executed to amend Exhibit B which revised hourly billing rates to the Agreement.

On May 6, 2022, by Resolution 22-14665, the Commission of the District approved Amendment No. 2 which increased the not to exceed contract price to \$1,400,000.

On February 21, 2023, by Resolution 23-14740, the Commission of the District approved Amendment No. 4 which increased the contract amount by \$100,000, for a revised contract price not to exceed \$1,500,000.

District staff has identified the need for additional mechanical, electrical and plumbing services for the train depot restroom, revisions to plans to accommodate the mechanical room supporting the splash pad, tasks related to exploring splash pad surfacing and trail materials selection, Department of Health permit resubmittal for splash pad, permit set plan submittal for the City of Wenatchee, stormwater management report for the City of Wenatchee shoreline permit, geotechnical and environmental subgrade mitigation, security camera system design, train depot power and fiber design, increase in meeting time and quantity, coordination due to extended project schedule, and construction management services. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend SA-TA No. 21-11370 with GreenWorks, P.C. to increase the contract amount by \$500,000 for a total revised contract price not to exceed \$2,000,000 and extend the contract term to March 31, 2026.

The General Manager has reviewed District staff's recommendation and concurs in the same.

### **ACTION**

### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District entered into a Services Agreement (SA No. 21-11980) on March 22, 2022, with APFS, LLC to provide Technical Project Management Resources, in an amount not to exceed \$250,000. Amendment 1 increased the not to exceed amount to \$499,000.

Resolution No. 22-14726 dated December 19, 2022, authorized an amendment to increase the not to exceed amount by \$1,500,000 to \$1,999,000. Resolution No. 23-14781 dated July 10, 2023, authorized an amendment to increase the not to exceed amount by \$231,000 to \$2,230,000.

District staff has identified the need for additional services for new and ongoing supplemental technical program management resources. District staff has acknowledged the significant benefits of leveraging this resource for technical program management, notably in broadening our capacity to efficiently manage an array of technology projects. This strategy has been instrumental in handling our expanding project portfolio without necessitating an increase in our internal headcount. The support and expertise provided by this resource are expected to continue as a vital supplement to our program management efforts through 2024, with plans to further utilize these services for a range of technology-specific initiatives through 2025. This approach underlines our dedication to operational efficiency and agility. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend SA No. 21-11980 with APFS, LLC in the amount of \$3,000,000, for a total revised contract price not to exceed \$5,230,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

### FACTUAL BACKGROUND AND REASONS FOR ACTION

The Commission, by Resolution No. 17-14215, delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less.

District staff prepared bidding documents for Bid 23-12920, Rocky Reach Large Unit Generator Coolers.

Sealed proposals were invited and published in accordance with RCW 54.04.070 and said bids were opened on December 28, 2023 at 2:00 P.M. Pacific Time in the offices of the District.

One (1) bid was received pursuant to that invitation. The bid exceeded the engineer's estimate by more than fifteen percent (15%).

RCW 54.04.080 precludes the District from awarding contracts for more than 15% in excess of the engineer's estimate. As a result, the bids were non-responsive and should be rejected. Resolution No. 17-14215 requires that the rejection of bids must come before the Commission for action when staff is recommending an action other than rebidding.

Pursuant to RCW 54.04.080, the District may procure the work on the open market and negotiate a contract rather than re-advertising if no bids are received. District staff recommends that, due to time constraints and project requirements, the Rocky Reach Large Unit Generator Coolers be procured by negotiation.

The General Manager of the District has reviewed District staff's recommendation and concurs in the same.

A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO ENTER INTO A SERVICES AGREEMENT (SA NO. 23-13225) WITH COLUMBIA RESEARCH SPECIALISTS, LLC. OF CHELAN, WASHINGTON FOR ROCKY REACH AND ROCK ISLAND PIKEMINNOW PREDATOR CONTROL

### FACTUAL BACKGROUND AND REASONS FOR ACTION

Resolution No. 17-14215 requires that the Commission, by resolution, authorize Service Agreements that exceed \$500,000.

Public Utility District No. 1 of Chelan County, Washington (District) owns and operates the Rocky Reach, Rock Island, and Lake Chelan Hydroelectric Projects. The District's operation of these projects is governed by the licenses granted by the Federal Energy Regulatory Commission (FERC) through the license articles and the District's Rocky Reach, Rock Island and Chelan Habitat Conservation Plans (HCPs).

Public Utility District No. 1 of Chelan County, Washington (District) has asked Columbia Research Specialists, LLC to conduct Northern Pikeminnow predator control using long-line fishing techniques which directly supports the Rocky Reach and Rock Island Habitat Conservation Plans (HCP). This program was a key contributing element to successfully meeting the HCP survival standards and more recently the 10-year check in survival studies at Rock Island and Rocky Reach Hydroelectric Projects.

Columbia Research Specialists, LLC of Chelan, WA has prepared a proposal to perform Rocky Reach and Rock Island Pikeminnow Predator Control for an estimated cost of \$200,000 a year for five (5) years, for a not to exceed amount of \$1,000,000.

Columbia Research Specialists, LLC has successfully performed these services on a yearly basis since 2005. It is District staff's recommendation that it is in the best interest of the District to enter into a five (5) year Services Agreement with Columbia Research Specialists, LLC for the above-described services.

The General Manager of the District has reviewed staff's recommendation and concurs in the same.

A RESOLUTION APPROVING A PURCHASE AND SALE AGREEMENT WITH RAVENWING RANCH, LLC FOR REAL PROPERTY LOCATED IN CHELAN COUNTY AND AUTHORIZING THE 2024 CAPITAL BUDGET ITEM

### FACTUAL BACKGROUND AND REASONS FOR ACTION

The Public Utility District No. 1 of Chelan County (District) is authorized by RCW 54.16.020 to acquire real property for a number of purposes related to its mission of providing utility services to the public.

Ravenwing Ranch, LLC (Ravenwing), owns approximately 4,910 acres of real property located in Chelan County, Washington (Property), generally in the Colockum area. The District is interested in purchasing the Property consistent with its statutory authority and long term strategic planning.

District and Ravenwing have negotiated a Purchase and Sale Agreement (PSA), which forms the basis for District staff recommendation. The PSA legally describes the Property and contains standard terms and contingencies for the purchase of real property. The General Manager has signed the PSA subject to Commission approval.

As provided in the PSA, the District will purchase the Property from Ravenwing for Five Million Three Hundred and Twenty-five Thousand Dollars (\$5,325,000.00), subject to, among other things, a feasibility study period during which time the District may study the Property's suitability for possible uses consistent with the District's goals.

To execute the purchase, a new 2024 capital budget item will be required for \$5,325,000 to cover the purchase of the property plus the additional amount of \$71,000 needed for the District's share of closing costs, insurance, taxes, and any studies as provided for in the PSA for a total project budget of \$5,396,000.

Staff recommends the Commission approve the proposed Purchase and Sale Agreement with Ravenwing and establish the corresponding 2024 capital budget item for the purchase. The General Manager has reviewed staff's recommendation and concurs in the same.
