RESOLUTION RATIFYING FIELD WORK ORDER/CHANGE ORDER NO. 25 AND FURTHER APPROVING FIELD WORK ORDER/CHANGE ORDER NO. 26 FOR THE SERVICE CENTER WITH PROJECT ABSHER CONSTRUCTION **COMPANY** OF PUYALLUP, WA **FOR** CONSTRUCTION OF THE SERVICE CENTER **PURSUANT GENERAL** PROJECT TO CONTRACTOR/CONSTRUCTION **MANAGER** (GC/CM) CONTRACT NO. 18-91

FACTUAL BACKGROUND AND REASONS FOR ACTION

On March 4, 2019, by Resolution No. 19-14327, the Commission of the District authorized the General Manager to invite sealed proposals to provide General Contractor Construction Manager (GC/CM) services to the District in support of the planned Service Center Project.

On April 15, 2019, by Resolution No. 19-14334, the Commission of the District approved the Service Center Project and adopted the project capital budget.

On July 1, 2019, by Resolution No. 19-14356, the Commission of the District authorized the General Manager to enter into Service Center Contract No. 18-91 with Absher Construction Company. In addition to the general terms and conditions, the Contract authorized \$500,000 for preconstruction services

On August 3, 2020, by Resolution No. 20-14477, the Commission of the District authorized the General Manager to enter into Guaranteed Maximum Price (GMP) Amendment No. 1 to Contract No. 18-91 with Absher Construction Company for site work construction in the amount of \$8,960,518, for a total revised contract amount of \$9,460,518, excluding sales tax.

On February 1, 2021, by Resolution No. 21-14524, the Commission of the District authorized the General Manager to enter into GMP Amendment No. 2 for construction of the Service Center in the amount of \$95,132,983, in addition to ratifying Field Work Order/Change Order Nos. 1-2 in the amount of \$206,005, for a total revised contract amount of \$104,799,506, excluding sales tax.

On July 19, 2021, by Resolution 21-14576, the Commission of the District ratified Field Work Order/Change Order Nos. 3-6 for construction of the Service Center in the amount of \$343,619, for a total revised contract amount of \$105,143,125, excluding sales tax. In addition, Resolution 21-14576 authorized the General Manager to execute Field Work Order/Change Orders (FWO/CO) up to a cumulative value of

\$1,000,000 and further authorized the General Manager to re-delegate project specific authority pursuant to Section 8 of Attachment No. 1 of Resolution 17-14215.

On June 6, 2022, by Resolution 22-14667, the Commission of the District ratified Field Work Order/Change Order Nos. 7-12 for construction of the Service Center in the amount of \$821,355, for a total revised contract amount of \$105,964,480, excluding sales tax.

On November 7, 2022, by Resolution 22-14709, the Commission of the District ratified Field Work Order/Change Order Nos. 13-17 for construction of the Service Center in the amount of \$930,729 for a total revised contract amount of \$106,895,209, excluding sales tax.

On February 21, 2023, by Resolution 23-14739, the Commission of the District ratified Field Work Order/Change Order Nos. 18-21 and further approved Field Work Order/Change Order No. 22 for construction of the Service Center in the amount of \$2,945,587 for a total revised contract amount of \$109,840,796, excluding sales tax.

On March 20, 2023, by Resolution 23-14747, the Commission of the District ratified Field Work Order/Change Order No. 23 and further approved Field Work Order/Change Order No. 24 for construction of the Service Center in the amount of \$5,232,532 for a total revised contract amount of \$115,073,328, excluding sales tax.

The District Commission by Resolution Nos. 17-14215 and 21-14576 delegated limited authority to the General Manager and the staff to execute field work orders under certain circumstances.

The work in FWO/CO No. 25 consists of conditions and work not anticipated or included in the original contract but within the scope of the contract. The District's staff has executed Field Work Order/Change Order No. 25, which is on file in the offices of the District and summarized as follows:

Field Work Order/Change Order No. 25 results in a net increase in the contract price of \$430,027 for a revised total price of \$115,503,355, (excluding sales tax), which the District's Engineers recommend be ratified.

Additionally, District Staff recommends execution of Field Work Order/Change Order No. 26 to increase the contract price by \$3,778,359 for a revised total price of \$119,281,714 (excluding sales tax). Field Work Order/Change Order No. 26 increases Contract Time for Phase 1 Substantial Completion due to weather delays and addresses delay impacts, resulting from District direction to stop work, for the Structural Steel trade package and partially addresses these impacts for the Electrical trade package.

The General Manager of the District concurs with staff's recommendation that Field Work Order No. 25 be ratified and further approve Field Work Order/Change Order No. 26.

A RESOLUTION DECLARING THAT NO BIDS WERE RECEIVED FOR ROCKY REACH UNITS C1 THROUGH C7 THRUST BEARING OIL COOLERS (BID NO. 22-12576) AND AUTHORIZING THE ROCKY REACH UNITS C1 THROUGH C7 THRUST BEARING OIL COOLERS BE OBTAINED BY NEGOTIATION

FACTUAL BACKGROUND AND REASONS FOR ACTION

The Commission, by Resolution No. 17-14215, delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less.

District staff prepared bidding documents for the supply of Rocky Reach Units C1 through C7 Thrust Bearing Oil Coolers. This bid is required to purchase sixty – four (64) new thrust bearing oil coolers to replace all existing coolers for the small Rocky Reach units on a schedule that aligns with unit overhauls or as individual coolers fail.

Sealed proposals were invited and published in accordance with RCW 54.04.070 and no bids were received on the closing date, March 28, 2023 at 2:00P.M. Pacific Time in the offices of the District.

Resolution No. 17-14215 requires that declaration that no bids were received must come before the Commission for action when staff is recommending an action other than rebidding.

Pursuant to RCW 54.04.080, the District may procure the work on the open market and negotiate a contract rather than re-advertising if no bids are received. District staff recommends that, due to time constraints and project requirements, the Rocky Reach Units C1 through C7 Thrust Bearing Oil Coolers be procured by negotiation, rather than re-advertising for bids.

The General Manager of the District has reviewed District staff's recommendation and concurs in the same.

A RESOLUTION AUTHORIZING ADDITIONAL FUNDS FOR SERVICE AGREEMENTS 04-03 AND 17-134 WITH OPEN ACCESS TECHNOLOGY INTERNATIONAL, INC. (OATI) OF MINNEAPOLIS, MINNNESOTA FOR WEBTRADER AND WEBACCOUNTING SERVICES

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District has a requirement for a comprehensive energy trading and scheduling system that is fully integrated with the NERC mandated electronic tagging (e-tagging) system. In addition, the District has a requirement to fulfill its data processing contractual obligations to its power purchasers.

webTrader (04-03)

The District used the competitive negotiation procedures set forth in RCW 39.04.270 and issued a Request for Proposal (RFP 04-03) in April 2004 for an automated Power Transaction Management System that would integrate e-tagging with the District's trading, scheduling and interchange accounting.

On September 7, 2004, the Commission approved Resolution No. 04-12595 authorizing a three (3) year contract with OATI, Inc. in an amount not to exceed \$800,000.

The Commission approved Resolution No. 08-13264 on February 25, 2008, authorizing additional funding in the amount not to exceed \$850,000, and a five (5) year term extension through May 2, 2008.

The Commission approved Resolution No. 11-13651 on May 2, 2011, authorizing additional funding in the amount of \$250,000, for a total not to exceed price of \$1,100,000 for the five (5) year term set to expire May 2, 2013.

The Commission approved Resolution 13-13797 on April 15, 2013, authorizing additional funding in the amount not to exceed an additional \$3,000,000, and a ten (10) year term extension through May 2, 2023.

webAccounting (17-134)

On September 5, 2017, the Commission approved Resolution 17-14174 authorizing a contract with OATI, Inc. in an amount not to exceed \$635,000 for energy accounting software.

The Commission approved Resolution 21-14552 on April 19, 2021, authorizing additional funding in the amount of \$600,000.

Staff has determined that OATI continues to be the best provider of these services and recommends that it is in the best interest of the District to authorize a change order extending both Agreements for a term of ten (10) years, and approving the expenditure of \$6,500,000 for both Agreements during that time period (May 2, 2023 – December 31, 2033).

The General Manager has reviewed District staff's recommendation and concurs in the same.

ACTION

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, WASHINGTON as follows:

Section 1. The District's General manager is hereby authorized to execute a change order with Open Access Technology International, Inc. to extend the referenced Agreements for a term of ten (10) years, through May 2, 2033, and to approve the expenditure of \$6,500,000 for both Agreements during that time period (May 2, 2023 – December 31, 2033).
