A RESOLUTION AUTHORIZING AN INCREASE IN THE INTERNAL NOT-TO-EXCEED AMOUNT FOR SERVICES AGREEMENT (SA) NO. 08-050 WITH ACCU-READ, INC., OF SPOKANE, WA TO CONTINUE TO PROVIDE METER READING SERVICES

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

On April 4, 2008, the District issued a request for proposals for contract meter reading services. The District received one proposal from Accu-Read, Inc. of Spokane, WA (Accu-Read).

Resolution No. 08-13328 dated May 12, 2008 authorized Services Agreement (SA) No. 08-050 with Accu-Read to provide Meter Reading Services, in an amount not to exceed that approved in annual budgets. On May 16, 2008, the District entered into SA No. 08-050 with Accu-Read to perform the services for an initial two year term at the billing rates set forth in the SA. The agreement allows extensions by addition of one year terms, or a portion thereof, and the District and Accu-Read have mutually agreed to continuing services annually since.

Resolution No. 17-14123, established an internal not-to-exceed amount as a more effective contract monitoring tool. At that time, an internal not-to-exceed amount of \$7,250,000 was approved and anticipated to cover five annual contract renewals beginning in May 2017.

District staff has identified the need for continued meter reading services through the completion of the District's AMI project. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Service Agreements and Amendments when the total contract price exceeds \$500,000. This internal authorization will allow for delivery of the same services described above for two additional one-year extensions, if needed.

District staff considers it to be in the best interest of the District and recommends increasing the authorized internal not-to-exceed amount for Services Agreement No. 08-050 with Accu-Read, Inc in the amount of \$1,250,000 for a total revised not to exceed of \$8,500,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District entered into a Services Agreement (SA-TA No. 19-10387) on October 24, 2019, with RH2 Engineering, Inc. to provide civil, structural, electrical, mechanical and site engineering services in an amount not to exceed \$199,000. On November 2, 2020, Amendment No. 1 was executed to increase the not to exceed amount by \$301,000 for a revised not to exceed contract amount of \$500,000. Amendments 2 and 3 updated annual hourly billing rates in accordance with the Agreement. The term of this SA-TA No. 19-10387 is through January 31, 2024 with the option to extend upon mutual written agreement.

District staff has identified the need for additional engineering services under this District-wide utilized Agreement. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend SA-TA No. 19-10387 with RH2 Engineering, Inc. to increase the not to exceed amount by \$500,000 for a total revised contract price not to exceed \$1,000,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

The District entered into a Services Agreement (SA-TA No. 20-10676) on February 4, 2020, with Pacific Engineering & Design, PLLC to provide civil and structural engineering services in an amount not to exceed \$195,000. On November 18, 2020, Amendment No. 1 was executed to increase the not to exceed amount by \$250,000 for a revised not to exceed contract amount of \$445,000. Amendments 2 and 3 updated annual hourly billing rates in accordance with the Agreement. The term of this SA-TA No. 20-10676 is through March 31, 2023 with the option to extend upon mutual written agreement.

District staff has identified the need for additional engineering services under this District-wide utilized Agreement. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend SA-TA No. 20-10676 with Pacific Engineering & Design, PLLC to increase the not to exceed amount by \$555,000 for a total revised contract price not to exceed \$1,000,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District entered into a Services Agreement (SA-TA No. 20-10987) on September 28, 2020, with Gray & Osborne, Inc. to provide civil and mechanical engineering services in an amount not to exceed \$250,000. On February 18, 2021, Amendment No. 1 was executed to increase the not to exceed amount by \$245,000 for a revised not to exceed contract amount of \$495,000. The term of this SA-TA No. 20-10387 is through December 31, 2024 with the option to extend upon mutual written agreement.

District staff has identified the need for additional engineering services under this District-wide utilized Agreement. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend SA-TA No. 20-10987 with Gray & Osborne, Inc. to increase the not to exceed amount by \$505,000 for a total revised contract price not to exceed \$1,000,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

A RESOLUTION REJECTING ALL BIDS AND DECLARING THAT NO BIDS WERE RECEIVED FOR THE SUPPLY OF THE DISTRIBUTION AND TRANSMISSION POLE BID (BID NO. 21-24) AND AUTHORIZING THE SUPPLY OF THE DISTRIBUTION AND TRANSMISSION POLES BE OBTAINED BY NEGOTIATION

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The Commission, by Resolution No. 17-14215, delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less.

District staff prepared bidding documents for the Supply of the Distribution and Transmission Poles.

Sealed proposals were invited and published in accordance with RCW 54.04.070 and said bids were opened on March 23, 2022, at 2:15p.m. Pacific Time in the offices of the District.

Three bids were received pursuant to that invitation. One bid proposal exceeded the engineer's estimate by more than 15%. The remaining two bid proposals did not meet bid specifications and included material changes to the terms and conditions of the bid.

District staff is of the opinion that the bids were non-responsive and should be rejected. Resolution No. 17-14215 requires that the rejection of bids must come before the Commission for action when staff is recommending an action other than rebidding.

Pursuant to RCW 54.04.080, the District may procure the work on the open market and negotiate a contract rather than re-advertising if no bids are received. District staff recommends that the distribution and transmission poles be procured by negotiation, rather than re-advertising for bids.

The General Manager of the District has reviewed District staff's recommendation and concurs in the same.
