#### RESOLUTION NO.

A RESOLUTION AUTHORIZING FINAL ACCEPTANCE OF WORK PERFORMED UNDER BID NO. 22-12271 WITH MCKINSTRY, CO. OF SPOKANE, WA AND AUTHORIZING RELEASE OF THE BOND IN LIEU OF RETAINAGE

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District Commission by Resolution No. 17-14215 delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less.

On April 11, 2023, the District entered into a contract (Bid No. 22-12271) with McKinstry CO. (Contractor) of Spokane Washington for the Rocky Reach Transformer Fire Protection Upgrade, in the amount of \$510,026. This contract was advertised for public bid as required by RCW 54.04.070 and .080. The bids received did not meet all statutory requirements. Pursuant to RCW 54.04.080 and Resolution No. 22-14719, the Commission rejected all bids as not responsive and authorized the District to obtain Rocky Reach Transformer Fire Protection Upgrade by negotiation.

The work in Field Work Order/Change Order Nos. 1 and 2 consists of schedule time extensions due to punch-list material order delays, and as-built drawings and Operation & Maintenance Manual completion. The District's staff has executed Field Work Order/Change Order Nos. 1 and 2, which are on file in the offices of the District and summarized as follows:

Field Work Order/Change Order Nos. 1 and 2 results in a change to the completion date. Resolution No. 17-14215 provides that this type of field work order shall be presented to the Commission for approval as part of the final acceptance resolution.

District staff has determined that the work required under the contract has been performed in accordance with the terms of the contract and recommends that the District accept the work.

District staff has determined that the completion of all contract work occurred on January 31, 2024. In accordance with the terms of the contract, the Contractor has provided a bond in lieu of retainage equal to 5% of the contract price.

The General Manager of the District concurs with staff's recommendations that the District accept the work performed by the Contractor and authorize the release of the related bond in lieu of retainage, subject to the requirements of the contract and state law.

<u>Section 1</u>. Field Work Order/Change Order Nos. 1 and 2 to Bid No. 22-12271 with McKinstry CO. for the work specified above, is hereby ratified.

Section 2. All the contract work required under Bid No. 22-12271 was completed on January 31, 2024, and the same is hereby accepted, subject to Section 2 hereof. Release of the Contractor's bond in lieu of retainage is authorized to be paid to the Contractor subject to Section 3 and Section 4 hereof, and subject to the provisions and limitations of Chapter 39.12 RCW (Prevailing Wages on Public Works) and 60.28 (Liens for Labor, Materials and Taxes on Public Works).

Section 3. This resolution shall not constitute an acceptance by the District of any work performed or goods supplied pursuant to the aforementioned contract, which are not in strict compliance with the contract terms and conditions.

Section 4. After the expiration of the forty-five (45) day period for giving the District notice of lien and after receipt of the Department of Revenue's certification of the Contractor's payment of taxes, the Employment Security Department's Certificate of Payment of Contributions, Penalties and Interest on Public works Contracts and the Department of Labor & Industries' Certificate of Release of the State's Lien on Public Works contracts and the District being satisfied that taxes certified as due or to become due are discharged and the filed claims of materialmen and laborers, if any, together with a sum sufficient to pay costs of foreclosing the liens and attorney's fees, have been paid, the District's General Manager is authorized and directed to file a claim against the bond in lieu of retainage in an amount equal to unpaid taxes and unpaid claims, together with a sum sufficient to defray the costs and attorney fees incurred in foreclosing the lien of such claims, and following payment of such claim, release the bond in lieu of retainage.

#### A RESOLUTION AUTHORIZING AMENDMENT NO. 1 TO SERVICES AGREEMENT (SA NO. 23-12876) WITH PYTHIAN SERVICES USA INC. TO PROVIDE IT CONSULTING AND MANAGED SERVICES

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District entered into a Services Agreement (SA No. 23-12876) on December 28, 2023, with Pythian Services USA Inc. to provide IT Consulting and Managed Services, in an amount not to exceed \$475,000 for Oracle and SQL database support through 2025.

District staff has identified the need for additional services for the design, planning and implementation of a new Azure Virtual Data Center and cloud data backup improvements. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Amendments to Service Agreements when the Amendment increases the total contract price to over \$500,000.

District staff recommends that it is in the best interest of the District to amend Services Agreement No. 23-12876 with Pythian Services USA Inc in the amount of \$600,000, for a total revised contract price not to exceed \$1,075,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

A RESOLUTION AWARDING SPECIFIC LINES TO GENERAL PACIFIC, INC. OF FAIRVIEW OREGON, REJECTING BIDS, AND AUTHORIZING THE 2025 TRANSFORMER PURCHASE AND SUPPLY (BID NO. 23-13135) BE OBTAINED BY NEGOTIATION FOR THE REMAINING LINES

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

On March 6, 2024, an invitation for sealed bids was published in accordance with RCW 54.04.070 and Resolution No. 17-14215 for the 2025 Transformer Purchase and Supply. Bid proposals were opened on April 23, 2024 in the offices of the District. Four bids were received (excluding sales tax) as tabulated on Attachment A.

The proposals were evaluated based on the evaluation criteria and formulas provided in the bid. The bid received by General Pacific, Inc. of Fairview Oregon for line items 17, 18, and 19 shown in Attachment A, is the lowest responsive and best bid in compliance with the plans and specifications for Bid No. 23-13135 and meets all statutory requirements. District staff recommends awarding Lines 17, 18, and 19 to General Pacific, Inc.

The remaining lines (1-16 and 20-32), all exceeded the engineers estimate, or were not bid. Resolution 17-14215 requires that the rejection of bids must come before the Commission for action when staff is recommending an action other than rebidding. Pursuant to RCW 54.04.080, the District may procure the work on the open market and negotiate a contract rather than re-advertising if no responsive bids are received. District staff recommends that, due to time constraints and project requirements, the 2025 Transformer Purchase and Supply be procured by negotiation, rather than re-advertising for bids.

The General Manager of the District concurs with District staff's recommendation.
