A RESOLUTION APPROVING FIELD WORK ORDER/CHANGE ORDER NO. 1 TO CONTRACT 19-34 FOR THE UNLEADED AND DIESEL FUEL SUPPLY

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District Commission by Resolution No. 17-14215 delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less. Authority was also granted to the General Manager and the staff to execute field work orders under certain circumstances.

On September 11, 2019, the District entered into a contract (Bid No. 19-34) with Coleman Oil Company for the Unleaded and Diesel Fuel Supply in the amount of \$2,918,000. This contract was advertised for public bid and was awarded as required by RCW 54.04.070 and .080. The bid by the Contractor was the low bid and met the District's specifications.

District staff desire to execute Field Work Order/Change Order No. 1, to add additional funds of \$1,400,000, for a revised not to exceed contract price of \$4,318,000 (excluding sales tax), and to extend the contract term for an additional year, for a revised completion date of September 15, 2023.

The General Manager of the District concurs with staff's recommendations that Field Work Order/Change Order No. 1 be approved.

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, WASHINGTON, as follows:

Section 1. The General Manager of the District, or his delegee, is hereby authorized to execute Field Work Order/Change Order No. 1, increasing the contract price by \$1,400,000 for a revised not to exceed contract price of \$4,318,000, as well as extending the contract term one year, for a revised contract completion date of September 15, 2023. A RESOLUTION AUTHORIZING AMENDMENT NO. 4 TO A SERVICES AGREEMENT (SA NO. 20-11026) WITH ABM INDUSTRIES, INC TO PROVIDE DISTRICT JANITORIAL SERVICES

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District entered into a Service Agreement (SA No. 20-11026) on July 27, 2020, with ABM Industries, Inc. to provide District janitorial services, in an amount not-to-exceed \$240,000. Amendments 1 through 3 added services and \$259,000.00 for a not-to-exceed dollar amount of \$499,000. They also extended the Service Agreement through September 30, 2022.

District staff has identified the need for continuing janitorial services for the District.

District staff recommends that it is in the best interest of the District to amend Services Agreement No. 20-11026 with ABM Industries, Inc. to continue janitorial services through December 31, 2023, in the amount of \$290,000, for a total revised contract price not-to-exceed \$789,000.

The General Manager has reviewed District staff's recommendation and concurs in the same.

Section 1.
