A RESOLUTION RATIFYING FIELD WORK ORDER/CHANGE ORDER NO. 1, AUTHORIZING FINAL ACCEPTANCE OF WORK PERFORMED UNDER BID NO. 18-88 WITH BRIVO CORP. OF CHENEY, WASHINGTON FOR UNIT PRICE DREDGING AND AUTHORIZING PAYMENT OF RETAINAGE

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District Commission by Resolution No. 17-14215 delegated authority to the General Manager to advertise, award and execute contracts when the total contract price is \$3,000,000 or less. Authority was also granted to the General Manager and the staff to execute field work orders under certain circumstances.

On March 4, 2019, the District entered into a contract (Bid No.18-88) with Brivo Corp. (Contractor) of Cheney, Washington for Unit Price Dredging, in the amount not to exceed \$353,400.00. This contract was advertised for public bid and was awarded as required by RCW 54.04.070 and .080.

The work in Field Work Order/Change Order No. 1 consists of conditions and work not anticipated or included in the original contract but within the scope of the contract. The District's staff has executed Field Work Order/Change Order No.1, which is on file in the offices of the District and summarized as follows:

The District staff recommend Field Work Order/Change Order No. 1 be ratified. Resolution No. 17-14215 provides that this type of field work order shall be presented to the Commission for approval as part of the final acceptance resolution.

District staff has determined that the completion of all contract work occurred on September 20, 2022. In accordance with the terms of the contract, retainage in an amount not exceeding 5% of the contract price has been withheld from the Contractor.

The General Manager of the District concurs with staff's recommendations that the District accept the work performed by the Contractor, ratify Field Work Order/Change Order No. 1 and authorize the payment of retainage due the Contractor, subject to the requirements of the contract and state law.

Section 2. All the contract work required under Bid No. 18-88 was completed on September 20, 2022 and the same is hereby accepted, subject to Section 3 hereof. Payment of retainage to the Contractor in the amount determined by the District's auditor to be due is authorized to be paid to the Contractor subject to Section 3 and Section 4 hereof, and subject to the provisions and limitations of Chapter 39.12 RCW (Prevailing Wages on Public Works) and 60.28 (Liens for Labor, Materials and Taxes on Public Works).

Section 3. This resolution shall not constitute an acceptance by the District of any work performed or goods supplied pursuant to the aforementioned contract, which are not in strict compliance with the contract terms and conditions.

Section 4. After the expiration of the forty-five (45) day period for giving the District notice of lien and after receipt of the Department of Revenue's certification of the Contractor's payment of taxes, the Employment Security Department's Certificate of Payment of Contributions, Penalties and Interest on Public works Contracts and the Department of Labor & Industries' Certificate of Release of the State's Lien on Public Works contracts and the District being satisfied that taxes certified as due or to become due are discharged and the filed claims of materialmen and laborers, if any, together with a sum sufficient to pay costs of foreclosing the liens and attorney's fees, have been paid, the District's General Manager is authorized and directed to withhold from the remaining retained amounts for claims the District may have against the Contractor, and the balance shall be paid to the Contractor. In the event said taxes, claims, expenses and fees have not been paid, the General Manager is authorized and directed to withhold an amount equal to unpaid taxes and unpaid claims, together with a sum sufficient to defray the costs and attorney fees incurred in foreclosing the lien of such claims, and the balance shall be paid to the Contractor.

FACTUAL BACKGROUND AND REASONS FOR ACTION

Resolution No. 21-14527 dated February 1, 2021 authorized Contract 20-10919 with Enhance Telecommunications, Inc. d/b/a ETI Software Solutions of Norcross, GA has prepared a proposal to perform Fiber Portal Replacement – Implementation and Support for an estimated cost of \$1,900,000.

District staff has identified the need for additional services and Managed Service Environment Subscription Licenses to increase functionality. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Service Agreements and Amendments when the total contract price exceeds \$500,000.

District staff recommends that it is in the best interest of the District to amend Contract 20-10919 with Enhance Telecommunications, Inc. d/b/a ETI Software Solutions in the amount of \$850,080, for a total revised not to exceed Contract Price of \$2,750,080 through the 7 year license term.

The General Manager has reviewed District staff's recommendation and concurs in the same.

A RESOLUTION APPROVING FIELD WORK ORDER/CHANGE ORDER NO. 3 TO BID NO. 21-30 FOR HYDRO GENERATION MECHANICAL SITE LABOR WITH BENDER CCP, INC. OF VERNON, CALIFORNIA

FACTUAL BACKGROUND AND REASONS FOR ACTION

Bid No. 21-30 – Hydro Generation Mechanical Site Labor is a unit price contract to provide labor, equipment and consumable materials to repair, overhaul, or rehabilitate the District's hydro-electric generating equipment.

On December 1, 2021, the District Commission approved Resolution 21-14593 which authorized the advertisement and award for Bid 21-30. The bid was subsequently advertised and awarded to the lowest responsive and responsible bidder. A contract was executed with Bender CCP, Inc. of Vernon, California on August 5, 2022, in a not to exceed contract price of \$5,000,000, exclusive of sales tax.

District Staff recommends execution of FWO/CO No. 3 to increase the not-to-exceed amount by \$7,000,000 for a revised not-to-exceed contract price of \$12,000,000, excluding sales tax. The additional funds will be used for continued support of the Rock Island Powerhouse 1 Unit Modernization and other services. This unit price contract is for an initial two (2) year term through August 15, 2024, with the option for two additional one (1) year extensions. In 2024, District Staff will evaluate this contract and if it is in the District's best interest to extend the term, a FWO/CO will be executed in accordance with Resolution 17-14215.

The General Manager of the District concurs with staff's recommendations that Field Work Order/Change Order No. 3 be approved.

The General Manager of the District has reviewed District staff's recommendation and concurs in the same.

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District is currently engaged in several large hydroelectric projects at Rock Island and Rocky Reach Dams. Resolution No. 17-14215 requires that the Commission, by resolution, authorize Service Agreements that exceed \$500,000.

Stantec Consulting Services, Inc. ("Stantec") of Bellevue, Washington has been performing professional engineering services for projects at the District's hydroelectric facilities.

District staff has determined that Stantec is the best qualified firm to provide the required services and that the proposed price(s) for the services are fair and reasonable. The total costs for the services to be provided by Stantec shall not exceed \$6,000,000 from the period of January 1, 2023, to December 31, 2027.

It is District staff's recommendation that it is in the best interest of the District to enter into a Services Agreement with Stantec for the above-described services. Services shall be provided when and as requested by the District according to written task assignments which define the scope, budget, and schedule for individual tasks. No work shall be undertaken by Stantec without a written task assignment.

The General Manager of the District has reviewed staff's recommendation and concurs with the same.

A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO ENTER INTO A SERVICE AGREEMENT (NO. 22-12509) WITH BLUE LEAF ENVIRONMENTAL, INC. OF ELLENSBURG, WASHINGTON FOR THE ROCKY REACH HCP CONFIRMATION SURVIVAL STUDY

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District is committed to continuing to fulfill its obligations as set forth in the Habitat Conservation Plan (HCP) to achieve no net impact (NNI) for Plan Species for the Rocky Reach Hydroelectric Project (RR). As part of achieving NNI, the District is required to measure the survival of Plan Species through the Rocky Reach Project, meet the Phase III Standard Achieved, and to confirm every 10 years that the survival standard continues to be met. Initial project survival studies at Rocky Reach were completed from 2004 through 2011 and Phase III Standards Achieved was successfully attained in 2011. Due to ongoing maintenance to address trunnion bushing issues in the small units at Rocky Reach deferment of a confirmation survival study from 2021 to 2023 was agreed to by the RR HCP Coordinating Committee on August 2, 2021. The confirmation project survival study is scheduled for mid-April through mid-June of 2023.

Blue Leaf Environmental, Inc. performed the Rock Island HCP Confirmation survival study in 2021. District staff are satisfied with the work and price.

Resolution No. 17-14215 requires that the Commission, by resolution, authorize Service Agreements that exceed \$500,000.

Blue Leaf Environmental, Inc. has prepared a proposal to perform the Rocky Reach HCP Survival Study for an estimated cost of \$1,128,115.

District staff has determined that Blue Leaf Environmental, Inc. is the best qualified firm to provide the required services and that the cost for said services of \$1,128,115 is a fair and reasonable price.

It is District staff's recommendation that it is in the best interest of the District to enter into a Services Agreement with Blue Leaf Environmental, Inc. for the above-described services.

The General Manager of the District has reviewed staff's recommendation and concurs in the same.
