A RESOLUTION APPROVING A LONG-TERM LICENSE AGREEMENT WITH INTERMOUNTAIN INFRASTRUCTURE GROUP, LLC FOR INSTALLATION, OPERATION AND MAINTENANCE OF TWO FIBER OPTIC CABLES LOCATED ON DISTRICT PROPERTY OR WITHIN THE DISTRICT'S HYDRO PROJECT BOUNDARY IN CHELAN AND DOUGLAS COUNTIES, WASHINGTON

FACTUAL BACKGROUND AND REASONS FOR ACTION

Intermountain Infrastructure Group, LLC (IIG) of Burlingame, CA requested the District to allow the installation, operation, and maintenance of two fiber optic cables, using a combination of overhead, underground and marine cables (Fiber Cables), across District property and within the Project Boundary of the Rock Island Hydroelectric Project No. 943. The purpose of the Fiber Cables is to complete redundant fiber routes to serve Microsoft Corporation's server center(s) in Grant, Douglas and Chelan Counties, Washington.

The Fiber Cables would enter District property from the Malaga Alcoa Highway and run North along the West side of the District's Rock Island Dam property in Chelan County until they enter the Columbia River. In the river, the Fiber Cables would be laid on the bottom for approximately seven miles until coming ashore across a small strip of land lying waterward of a privately owned parcel, and at Kirby Billingsley Hydro Park in Douglas County, Washington.

The District developed a twenty (20) year license agreement (License Agreement), with the option for two, twenty (20) year renewals. The annual license fee of \$13,800 with a three percent (3%) annual increase was determined by an independent third-party appraiser. IIG has agreed to the terms of the license, pending approval by the District's Board of Commissioners.

IIG has acquired all permits required to complete the project and provided copies of the same to the District. In addition, District staff has confirmed that the License Agreement must be included on the End of Year Conveyance Report to the Federal Energy Regulatory Commission (FERC) but that no additional FERC filing is required prior to execution of the License Agreement.

District staff recommends the Commission approve the twenty (20) year License Agreement with IIG with an annual license fee of \$13,800 and a three percent (3%) increase per year, and the option of two, twenty (20) year renewals.
