Overview of Options

Use some surplus power to attract industries and jobs?

BENEFITS: ECONOMY (\$100+ MILLION) INVESTMENT: UP TO \$100 MILLION

Many local industries benefit from our low cost power, and some industries have chosen to locate here for this very reason. With proper incentives, other companies that value low-cost power or carbon-free energy could find our county quite attractive. Should your PUD play an even greater role in attracting new industries and jobs—in cases where the value of energy used to attract the businesses is offset by added jobs and industry in the community?

Provide student mentoring and education opportunities?

BENEFITS: EDUCATION, JOBS INVESTMENT: \$2 MILLION

A high school job shadow or mentoring program could provide local students with opportunities to learn about interesting and well paying jobs. Your PUD could also team with other utilities or institutions to develop a curriculum that helps local students or those seeking a career shift to prepare for high-demand utility jobs. These activities could create more opportunities for locally grown talent to call this county home.

Take an active, proactive role in economic development?

BENEFITS: ECONOMY INVESTMENT: \$1 MILLION

Your PUD has historically taken a passive approach to economic development, and is somewhat limited by state laws. But appointing an expert dedicated to partnering with agencies and businesses on collaborative projects could bring new opportunities to light. Projects would have to be within the limits of authority for a PUD. Should your PUD designate an economic development expert and actively seek out and support economic opportunities that make sense?

This is only an example and I don't know if it's a feasible one, but my point is to look carefully and continuously at existing infrastructure and look for new ways to gain revenues from them.

I feel that the CCPUD should have a clear, informed, and reasoned policy in place before providing service to "bitcoin miners," or any other similar enterprises (there are other, lesser known virtual money systems; and more will surface.) The following is a comment I sent to the Wenatchee World after reading the bit coin mining story last week: Bitcoin mining essentially is the creation of a virtual currency by using computing power fueled by lots of electricity. Bitcoins have no intrinsic value. They are not backed by any government or bank. They are not backed by any physical assets such as gold or property. They have volatile price variation. It's peak value was \$1151 a year ago, today it's \$281. It's a highly speculative currency. The FBI's position is "it is a violation of federal law for individuals....to create private coin or currency systems to compete with the official coinage and currency of the United States." My point is that is risky for the PUDs to acomodate these virtual money factories...if they fail, either by a collapse of the bubble, or by legal shutdown, the PUDs (and by us, the stakeholders,) are left holding the bag for any infrastructure investments or loss of surplus sales profits. Among other things, the electricity contracts should have variable rates whereby the PUD wouldn't lose money if it was not able to sell surplus power at higher rates. ...
