• Tiffanie Davis, Human Resources Analyst, led the pledge and presented information on learning teams and how they are used

Resolution 9 was moved to the consent agenda; the agenda was approved as revised

Wholesale Energy Trading Resolution Update

(see Chelan PUD website for presentation)

- Jayme Mitchell, Senior Risk Analyst, and Mike Bradshaw, Term Power Trader, gave an update on the proposed Whole Energy Trading Resolution, which addresses current market environment conditions
 - Separates fixed-price transactions from index-price transactions recognizing their different characteristics
 - Provides for more conservative limits, mitigating the risk of purchasing at high market prices while accepting more revenue volatility
 - o Allows for modeling choices to be made at the Power Risk Management Committee level providing flexibility to determine the best approach for the type of analysis

Northwest Resource Adequacy Program

- Gregg Carrington, Managing Director of Energy Resources, gave an update on the development of the Northwest Power Pool's Resource Adequacy Program
- The 18 largest utilities are helping design the Resource Adequacy (RA) Program; the RA program will be voluntary to join, but will require a commitment to the program once joined
 - o The group is working on program design objectives
- What does this mean for Chelan PUD?
 - We are in good shape to be able to serve load, although there may be times when we need to make market purchases; we also may become more conservative in the future

Legislative Update

- Tracy Yount, Director of External Affairs, and Shaun Seaman, Government/External Affairs Program Manager, gave an update on legislative session activities
- Reviewed utility input and concerns with the proposed oil-free turbine legislation; consensus is a preference for the tax parity bill from last session
- As budgets are considered, the Department of Health has requested \$100M to address Coronavirus
- Reviewed other bills that would have impact on the District

Manager Items

- Kirk Hudson, Managing Director of Generation and Transmission, gave an update on the Puget Sound Energy McKenzie Beverly transmission line repair
 - o Repairs to the line were completed on February 21, restoring our back-feed capabilities for any outages near Leavenworth, Plain, or Lake Wenatchee
- Steve Wright, General Manager, updated Commissioners on several items
 - Stehekin outreach in Stehekin has been scheduled for March 26; a second outreach trip will be scheduled in May or June
 - o California Independent System Operator (CAISO) proceedings on governance
 - The District joined with the Public Generating Pool last week to submit comments on what fixes would need to be put in place to mitigate governance risks for those outside of California; there will be a public hearing in the next 2 weeks
 - o Coronavirus asking staff to avoid all non-essential travel in March; we provide an essential service and a significant problem could undermine our ability to carry out essential duties
