 - Provided an update on the emergency management services campus in Olds Station
 - Will include 3 buildings including a secure area for vehicle searches, motor pool building, and coroner's office
 - o Malaga Waterfront Park Mike Kaputa, Natural Resources Director
 - The county has purchased a couple parcels
 - Reviewed 30% design schematics; expect final design cost estimate in the next month
 - o Stehekin Community Planning Mike Kaputa
 - Pioneer fire last summer deferred the County's Stehekin plan

- County is developing a plan to address needs in Stehekin; community meetings scheduled May 14-15

 - $\circ\,$ Thank you to the PUD for riverfront park improvements
 - $\circ\,$ Working on joint community education around Fourth of July fireworks

 - $\circ\,$ Project to double the size of the City's water main will begin soon
 - $\circ\,$ Test drilling for alternative water source may provide water for an all-pumped system
