Wenatchee High School Advanced Energy Management Team Presentation

- Jim White, Principal Energy Conservation Engineer, introduced the students of the Advanced Energy Management Team from Wenatchee High School
- The team showcased their efforts to lower energy usage of several commercial buildings, helping buildings meet energy efficiency regulations
- The team worked with PUD staff to monitor energy savings
- Commissioners expressed their appreciation for the great job the students have done presenting this information; thanks to Jim White for helping lead this collaboration
- Dr. Gene Sharratt recognized the District leadership and Commissioners for engaging in this program and school officials for supporting the program

Washington State Department of Health: Helion Regulatory Requirements

- Brett Bickford, Managing Director Generation and Transmission, introduced Washington State Department of Health Office of Radiation Protection staff Jill Wood, Director, John Martell, Associate Director and Richard Montemarano, X-ray Section Manager
- Reviewed:
 - Agency history
 - o Key points of the agreement between the Nuclear Regulatory Commission (NRC) and Washington state
 - The agreement allows the NRC to relinquish their regulatory authority to the state; at a minimum the state must meet federal regulatory standards, but can set higher standards
 - This allows the state more flexibility to address local concerns and NRC assesses the state program annually
 - o The difference between fusion and fission and how the Department of Health is involved with fusion
 - How radioactive waste is handled in various scenarios and radiological emergency preparedness
 - Licensing process and public engagement

Transmission Interconnection Update

- Steve Wickel, Manager Transmission and Distribution Engineering, reviewed transmission updates including:
 - o Open Access Transmission Tariff
 - o Federal Energy Regulatory Commission
 - o Interconnection studies and current interconnection queue; the queue currently contains five applicants
 - System upgrades and upgrades that benefit the District
 - In the absence of exclusivity, where an upgrade provides additional value to Chelan PUD, a costshare proportional to the benefit received by Chelan PUD is proposed

Fifth Street Redevelopment Update

- David Lodge, Manager Project Delivery, and Laine Heikel, Senior Project Manager, provided an overview of the next steps for the old headquarters building on the Fifth Street campus
- Recommendation for next steps is to clear the site, including demolition of the former headquarters building
- A resolution to advertise a bid for demolition and proceed with the demolition if a bid is received that is within the engineer's estimate

Manager Items

- Kirk Hudson noted the quarterly project and contract summary reports were included in the meeting packet
- Daniel Appel, Staff Attorney, provided a Regional Water update regarding the Crown-leased water rights
 - o The previous Mitigation Agreement terminates after this year's irrigation season as per the fifth addendum executed last October
 - o This new temporary water right agreement will cover the 2026-2029 irrigation seasons and will automatically terminate in 2029; at that point the Regional water right will return to Trust
 - o Regional will receive just under \$200k annually; unlike the past agreement, the new agreement will not require annual approvals
- Brett Bickford reported on Helion open houses and other events held May 6, 7, 8, and 14
 - Positive feedback from the community
 - Next steps include: a PUD lease agreement for use of property, permitting process with Chelan County including environmental reports and a conditional use permit for generator building, and the Department of Health (DOH) will assemble the license package and share it with the County
- Thank you for the DOH presentation this morning; thanks to Helion team for their community involvement
- John Stoll, Managing Director Customer Utilities, reported on Stehekin community meetings held May 14, 15
 - o Stehekin community meetings were held in collaboration with Chelan County
 - o Powerhouse tour provided by Bob Nielsen, Stehekin Operations Attendant
 - Community meeting held at the school; John shared information about the Advanced Metering Infrastructure (AMI) project
 - The AMI data is critical to set the foundation for future power recommendations

- Commissioners echoed the positive sentiments shared by the community and appreciated the opportunity to hear from the community
- Thanks to Mike Kaputa at Chelan County for organizing the visit
