# **Real Estate Delegated Authority**

- Erik Wahlquist, General Counsel, reviewed proposed changes to delegated authority for real estate transactions
- Objectives are to combine the two current resolutions, better define routine transactions, and delegate authority to the General Manager (rather than to staff)
- Surplus or sale of real property, along with purchase of real property would still come to the Board for approval

#### **Surplus Property Proposal**

- Lisa Graves, Real Estate Specialist III, requested a public hearing to consider surplus of approximately 45 acres near Beebe Bridge park
- Douglas County Fire District 4 has identified need for a fire station in that area; the PUD does not have a need for the property as it is not within the project boundary
- The majority of the property is not useable due to very steep terrain
- A third-party appraisal valued the property at \$95k

# **Regional Transmission Planning Organization Contracts**

- Kirk Hudson, Managing Director of Generation and Transmission, reviewed anticipated changes to the Regional Transmission Planning Organization beginning January 1, 2020
- The new entity (NorthernGrid) is a result of combining ColumbiaGrid and Northern Tier Transmission organizations
- Plan is to file documentation with FERC later this month for review

- The price of the parcel has been questioned
  - The parcel was appraised and while this amount is slightly higher than the appraisal, but is lower than nearby properties; the property market was depressed in 2008, 2009, and 2010

- Ron Slabaugh, Water/Wastewater Manager, and Ingrid Miller, Debt and Grants Compliance Program Manager, shared the good news that the District has received additional funding for the Peshastin project from the Department of Ecology including \$745k in a low-interest loan and \$412k grant

• This helps with some additional costs, but we will still have some level of costs to address in rate planning

- Suzanne Grassell, Government Affairs Program Manager, and Jeff Osborne, Senior License Compliance Specialist, reported on the recertification of Lake Chelan Project by the Low-Impact Hydropower Institute
  The Institute board looks at projects from environmental, cultural, and natural resources perspectives
  - Certification is through September 2022
- John Wasniewski, Energy Analyst I, reported our application to the Department of Commerce for incremental hydro at Lake Chelan as a result of efficiency gains has been accepted as renewable energy
  The current target is defined as 15% of our load; this gain was about a 5% unit efficiency gain
- Kim Craig, Public Information Officer, shared a video from Foundation for Water and Energy Education (FWEE) advertising the Seattle Sounders Hydro Appreciation Day on July 21
