Service Center Sitework Construction

- Jeff Osborn, Senior License and Compliance Specialist, shared the concerns about conditions in the Chelan River Gorge
 - o Engineers report increased concern over hillside stability near Reach 3 in the Chelan Gorge. Decision to suspend the annual whitewater event normally scheduled in September.
 - o FERC will be notified, Lake Chelan EAP will be updated, notifications pending to Chelan County Sherriff, City of Chelan council, key stakeholders; area signage is under review.
- Kerri Wendell, Customer Relations Manager, provided the latest COVID19 Customer Impacts Update
 - o Data remains consistent with prior reports
- Steve Wright Governor proclamation to suspend the disconnect notices coincides with current Board directive set to expire at the end of July
 - o District Plans to allow this to lapse, move to making payment arrangements as the next steps with those accounts that are accruing large late balances
- Steve Wright addressed an all-employee email coming out to staff today
 - o Increased cases county-wide, causing increased concern. 3 confirmed positives at the District.
 - Remote working will continue through the end of the year, for those who are able
 - o Labor union supports using masks and social distancing in tandem. Discipline potential if employees are non-compliant.
 - New un-manned temperature station located at 5 District locations
