The regular meeting of the Commission of Public Utility District No. 1 of Chelan County, Washington, was held in the office of the District, 327 North Wenatchee Avenue, Wenatchee, Washington, on September 6, 2016, at the hour of 10:00 a.m., pursuant to proper notice thereof.

Commissioners present were Dennis Bolz, Ann Congdon and Garry Arseneault. Commissioner Carnan Bergren participated via telephone. Commissioner Smith was excused. In attendance were General Manager Steve Wright, General Counsel Erik Wahlquist and Clerk of the Board Sheila Salmon.

Bill Kamenski led the Pledge of Allegiance and provided a safety minute.

Secretary Bolz presented the Agenda for approval. Agenda item 9 was moved to the Consent Agenda. The amended agenda was approved as written.

<u>LocalTel TV Conversion</u> Mike Coleman, Managing Director of Fiber and Telecom, and Dimitri Mandelis, LocalTel president reported the conversion to digital TV service on August 22, 2016 went extremely well.

North Wenatchee Master Plan - Steve King, Director of Community and Economic Development provided the presentation to Commissioners. (See www.chelanpud.org for the presentation.) Plans are in 2018 to start construction with completion in 2020.

Asset Management Generation Asset Program - Manager Janel Ulrich, Generation Asset Program Manager, presented "The Evolution of Asset Management at Chelan PUD" (See www.chelanpud.org for the presentation.) Long term plans will have more condition information and risk assessment. Work justification to utilize asset strategies built in a standard way. A revolution to a new "language" around asset decision-making: Clear, concise, repeatable and standardized.

<u>Suncrest Fire Update</u> – District staff Steve Wickel and Tim Petit reported on the August 27, 2016. Two transmission lines were removed resulting outage for 3,000 customers. Lines were restored on Tuesday, August 30, 2016.
