President Arseneault called the meeting to order at 10:01am

Pledge of Allegiance and Safety Minute

Cycle of Personal Ownership (CPO) Winner Recognition

 Steve Wright, General Manager, recognized November CPO winners Loretta Coonfield, Senior Accounting Analyst, and Todd Walsh, Senior Systems Analyst

Advanced Metering (AMI) Opt Out Follow Up

(see Chelan PUD website for presentation)

- Lindsey Mohns, Customer Utilities Business Manager, gave an update on the AMI opt out policy reflecting Commissioner guidance and updated information on meter capabilities
- Ray Potter, Journeyman Meterman, noted that it is not feasible to refurbish analog meters, they can only be adjusted slightly before requiring disposal
- Staff will move forward with the one-time opt-out fee set at zero with an ongoing study of costs and the monthly fee set at \$50 with a 50% discount for low-income senior and disabled customers
- Commissioners are interested in offering an analog meter option, at a higher monthly cost
- Public comment will be accepted until December 30, 2019; all comments will be shared with Commissioners

Service Center Facilities Update

(see Chelan PUD website for presentation)

- Dan Frazier, Director of Shared Services, and David Lodge, Project Manager II, gave an update on the Service Center, proposing an additional 10,000 sq. ft. be added to the building to accommodate additional program understanding and growth
- Designing the building to near-full capacity diminishes the District's resiliency to respond to future needs
- Space allocation per person was reviewed against a benchmark; the additional 10,000 sq. ft. would get us closer to the State standard and add back in some collaborative spaces that had been eliminated
- Adding that space now will cost \$5-6M versus a cost of \$10.8-13M later depending on timing
- Business case alternative options would be equal or more costly if we applied updated assumptions
- Commissioners expressed support for adding an additional 10,000 sq. ft. to the Service Center building A

Public Power Benefit (PPB) Program

- Felicity Saberhagen, District Services Business Manager, gave an update on 2019 PPB funding and presented recommendations for 2020 funding
- \$125,000 remains of 2019 funding; Commissioners support using those funds for Discovery Center exhibits
- The 2020 update will include: overall program update, revised financial funding criteria, and decision on remaining 2020 funds

Chelan-Manson Transmission Outreach and Alternative Selection

(see Chelan PUD website for presentation)

- Steve Wickel, Transmission Engineering Manager, and Jenna Rahm, Customer Outreach Specialist I, reviewed outreach to date; no public comments or questions were received during the outreach process
- The proposed plan is to rebuild the line from Chelan Falls switchyard to the Union Valley substation
- This is the first big project out of the fire hardening risk assessment; it is costly, but the right thing to do

Fish & Wildlife Update

- Alene Underwood, Fish & Wildlife Manager, Ian Adams, Hatchery Maintenance and Operations Manager, and Catherine Willard, Senior Fisheries Biologist, gave an update on the fisheries program
- Reviewed effectiveness of new Passive Integrated Transponder (PIT) tag antenna array at Rock Island, which has improved detection accuracy
- Both Rocky Reach and Rock Island licenses include articles for resident fish stocking to enhance recreational fishing opportunities; locations are determined by Washington Department of Fish and Wildlife
 In 2019 Chelan PUD stocked nearly 215,000 resident fish in Chelan and Douglas county lakes
- Reviewed Habitat Conservation Plans (HCP) Tributary Committees and Planned Species funds and funded projects
