## **Cash and Investment Topics**

New Board Designated Fund – as directed by Resolution 20-14424
 Electric Rate Support Fund
 Established by Board in 2020 – 2024 Rate Plan
 Directed staff to make deposits annually
 Annual calculation: electric rate revenue X cumulative increase %
 1st annual deposit December 2021
 Include in year end Board Quarterly Financial Review (Feb. 2022)

Investment and Banking Resolution – annual review process
 Authorized signer updates due to staffing changes
 Resolution request likely spring 2022

Develop Board guidance for fund use in 2022

  Existing SBPA supports the 2008B variable rate bonds
  The SBPA expires July 2022
  Desirable to extend or replace prior to expiration
  Plan to request Board approval in early 2022
