#### RESOLUTION NO.

A RESOLUTION AMENDING THE DISTRICT'S WATER RATE SCHEDULES TO ESTABLISH A RATE EQUALIZATION CHARGE SPECIFIC TO WATER CUSTOMERS WITHIN THE PESHASTIN WATER SYSTEM SERVICE AREA

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

Public Utility District No. 1 of Chelan County ("District"), in compliance with RCW 54.24.080, is required to establish, maintain, and collect rates and charges for electric energy and water and other services, facilities, and commodities sold, furnished, or supplied by the District.

Pursuant to RCW 54.16.030, the District has the authority to acquire and operate waterworks and irrigation plants and systems for the purpose of furnishing inhabitants of the District's service territory with water for all uses. In response to a request made by the Peshastin Water District ("PWD") that the District acquire and operate the PWD systems, the District Commissioners authorized the General Manager to negotiate and execute a water system transfer agreement with the PWD. The agreement was executed in September 2023 and officially closed on March 26, 2024.

Terms of the agreement specified that the District would not pay any monetary consideration for acquiring the assets of PWD but would pay outstanding PWD liabilities that encumbered the assets transferred to the District, and these liabilities would remain the obligation of the PWD service area. The acquisition created two potential funding needs: replacement of prior outstanding PWD external loans that were funded through small and large warehouse surcharges; and a strategy to fund construction costs for future planned capital projects. On December 18, 2023, staff presented initial internal loan terms and rate adder options to cover the funding needs.

On January 17, 2024, staff hosted a public information meeting in Peshastin to present to the PWD community members staff's initial recommendation for a rate adder that would offset the costs of an internal loan for future planned capital improvements. A public rate hearing was held at the District's Service Center on January 22, 2024.

On February 5, 2024, the board authorized, via Resolution No. 24-14858, a loan from the Financing Facilities System to retire and replace prior outstanding PWD external loans in an amount not to exceed \$1,040,000 with a loan term of 10 years. The debt service for the internal loan will be supported through the assessment of small and large Warehouse Tank Surcharges established via Resolution No. 24-14857. Commissioners directed staff to continue to pursue additional options for

planned capital project funding and rate adders to be presented at the next regularly scheduled board meeting.

On March 18, 2024, staff presented an alternative funding option that would minimize impacts to the customers served by the Peshastin water system while proactively generating cash flow to contribute to the future planned capital projects. Staff's proposal included the development of a rate equalization charge that would cause revenue, on a customer class basis, to approximate the PWD's previously adopted revenue forecast and rate plan.

After hearing staff's presentation, the Commission adopted the following motion during the March 18, 2024 meeting directing staff to:

Establish a rate equalization charge, to be effective June 1, 2024, for all customers within the Peshastin Water District service area such that the monthly revenue from each customer class is expected to be approximately the same as under the Peshastin Water District's current rate schedules, and to design the rate equalization charge to approximate the expected revenue in the 2021 rate plan approved by the Peshastin Water District over the next three years.

In accordance with the Commission's direction, staff developed monthly charges to apply equally to each customer in the same class in the Peshastin water system. District staff recommends that it is in the best interest of the District to amend the Water Rate Schedules to include the rate equalization charge as described herein.

The General Manager has reviewed staff's recommendation and concurs in the same.

After fully considering the public presentations by staff, comments from members of the public including Peshastin water customers, and the Staff Report, the Commission concurs with staff's recommendation.

#### ACTION

# IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, WASHINGTON, as follows:

<u>Section 1</u>. Requirements for meetings and notices as established by Resolution No. 18-14256 have been met and exceeded.

<u>Section 2</u>. The water rates set forth in Exhibit "A" attached hereto are determined to be fair, reasonable, necessary, and non-discriminatory. Effective June 1, 2024, the District's Water Rate Schedules shall be amended by adding a monthly rate equalization charge for the customers within the Peshastin Water system service area as described herein.

Section 3. The adoption of this rate resolution is not a major act under the State Environmental Policy Act (SEPA), and as such is categorically exempt under SEPA guidelines, WAC 197-11-800(14)(i).

<u>Section 4</u>. All prior resolutions inconsistent with this resolution are hereby rescinded and superseded.

#### A RESOLUTION DECLARING SOUTHERN STATES LLC OF GEORGIA AS THE SOLE SOURCE SUPPLIER OF CSH-B 245kV CIRCUIT SWITCHER 6-900 FOR USE AT THE SUMMIT OF STEVENS PASS

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The District determined the need for a CSH-B 245 kV Circuit Switcher 6-900 to replace the existing one located at the Summit of Stevens Pass, which was custom built by Southern States, LLC in 2004 to fit on a 50-foot tall support structure required to maintain adequate clearance from snow and surrounding forest.

District staff have determined that only Southern States, LLC can manufacture this custom-built circuit switcher and operating mechanism, which will allow a replacement without the need for costly redesign and reconfiguration of the structural and electrical elements necessary to safely and reliably operate a different type of circuit switcher at this location.

Pursuant to RCW 54.04.070 and 39.04.280, the District may, when there is clearly and legitimately a sole source of supply, waive the statutory competitive bidding requirements otherwise applicable to the purchase of equipment. Resolution No. 17-14215 requires that a declaration for sole source purchases over the statutory limits (\$60,000 per month) must come before the Commission for action.

District staff has determined that it would be in the best interest of the District to designate Southern States, LLC as the sole source supplier for CSH-B 245kV Circuit Switcher 6-900 in an amount not to exceed \$158,200 (exclusive of freight charges, which will be reimbursed at cost). Staff also recommends that the competitive bidding requirements of RCW 54.04.070 be waived.

The General Manager has reviewed staff's recommendations and concurs in the same.

#### ACTION

Section 2. The competitive bidding requirements of RCW 54.04.070 are hereby waived due to the designation of Southern States, LLC as the sole source supplier for CSH-B 245kV Circuit Switcher 6-900.

<u>Section 3</u>. The General Manager or his designee is authorized to enter into a purchase contract with Southern States, LLC for the purchase of CSH-B 245kV Circuit Switcher 6-900 at a cost not to exceed \$158,200 (exclusive of freight charges, which will be reimbursed at cost) without prior Commission approval. A copy of the contract will be on file in the offices of the District.

A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO SELL A 5.6 ACRE PARCEL OF REAL PROPERTY IN DOUGLAS COUNTY, WASHINGTON, LOCATED ALONG US HIGHWAY 2 NEAR ROCKY REACH DAM, TOGETHER WITH AN ACCESS EASEMENT, TO PUBLIC UTILITY DISTRICT NO. 1 OF DOUGLAS COUNTY

#### FACTUAL BACKGROUND AND REASONS FOR ACTION

The Public Utility District No. 1 of Chelan County (District) is a Washington municipal corporation authorized under the laws of the State of Washington, RCW 39.33.010, to sell real property to the state or any municipality or any political subdivision thereof, on such terms and conditions as may be mutually agreed upon by the proper authorities of the subdivisions concerned.

The Public Utility District No. 1 of Douglas County (Douglas) has a need to acquire property to site a substation in the vicinity of its Rocky Reach switchyard and existing transmission lines.

In 2021, the District and Douglas were aware of Washington State Department of Transportation's (WSDOT) pending surplus of undeveloped right-of-way near Rocky Reach dam. Both District and Douglas had interest in acquiring portions of the WSDOT property to meet their respective needs. However, WSDOT would sell the entirety of the surplus parcel to only one entity, and the District had the first option as the adjoining owner. The District and Douglas entered into an interlocal agreement in 2021, setting forth the parties' desire to work cooperatively so that Douglas could acquire the property it needed after the District's acquisition from WSDOT.

The District completed the acquisition from WSDOT in December 2022. The District and Douglas have since worked together and completed the process to segregate a 5.6 acre parcel (Subject Property) generally located under two of Douglas' existing transmission lines. The legal description for the Subject Property is on file in the District's offices. The sale price of \$186,000 is market value, established by appraisal. Access to the Subject Property will be by easement on a portion of Lincoln Rock Rd.

Staff recommends the District approve the sale of the Subject Property to Douglas. The General Manager has reviewed staff's recommendation and concurs in the same.

#### ACTION

IT IS RESOLVED BY THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF CHELAN COUNTY, WASHINGTON, as follows:

<u>Section 1</u>. The Board of Commissioners hereby authorizes the sale of the Subject Property to Douglas for \$186,000, and authorizes the District's General Manager, or designee, to take such further steps as may be required to complete the sale to Douglas.
