A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO ENTER INTO A ROAD DECOMMISSIONING AGREEMENT WITH CHELAN COUNTY NATURAL RESOURCES DEPARTMENT

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District owns and operates the McKenzie – Beverly 115kV transmission line, which was constructed in the late 1920s in conjunction with the Rock Island Hydro Project. Approximately 20 miles of the transmission line is located within the Okanogan Wenatchee National Forest, where it traverses a rugged section of the Cascade Range.

The United States Department of Agriculture Forest Service (USFS) has renewed the District's Special Use Permit (SUP) for the McKenzie Beverly Transmission Line. Re-issuance of the permit required completion of an Environmental Assessment consistent with the National Environmental Policy Act along with formal consultation and Biological Opinions from the National Oceanic and Atmospheric Administration Marine Fisheries Service and United States Fish and Wildlife Service who consulted on the effects of the USFS's issuance of the new SUP for continued maintenance under the proposed operating plan on listed species under the Endangered Species Act. The District will undertake several compensatory mitigation projects that offset unavoidable impacts from implementing the operating plan for the transmission line. These projects include decommissioning 8.0 miles of non-system roads on National Forest Lands in the Nason Creek drainage and 1.2 miles of roads on land owned by the Western Rivers Conservancy. In addition, a dispersed campsite will be decommissioned, and the District has authorized riparian restoration in an unused transmission corridor. These mitigation actions address the unavoidable impairment of ecological function caused by continued maintenance of the transmission line and should improve ecological function within the Nason Creek and Wenatchee watersheds consistent with Forest Service's Aquatic Conservation Strategy.

District staff have worked closely with the Chelan County Natural Resources Department (CCNRD) on several recent projects including the Upper White Pine restoration. As a result, staff were able to collaborate with CCNRD who have expert knowledge of the Nason Creek drainage and partner with them to identify roads to be decommissioned within the watershed to provide the compensatory mitigation required by the SUP. CCNRD has the unique expertise to design, bid and construct the road decommissioning work required by the SUP.

District and CCNRD staffs have negotiated an agreement to complete the necessary road decommissioning work for a not to exceed cost of \$490,000.

Staff recommends the Board of Commissioners authorize the General Manager to execute the agreement with CCNRD, a copy of which is on file in the offices of the District.

The General Manager has reviewed staff's recommendation and concurs in the same.

A RESOLUTION AUTHORIZING THE GENERAL MANAGER TO ENTER INTO A SPECIAL USE PERMIT WITH THE UNITED STATES DEPARTMENT OF AGRICULTURE, FOREST SERVICE, THAT PROVIDES FOR CONTINUED SAFE OPERATION AND MAINTENANCE OF THE MCKENZIE - BEVERLY 115KV TRANSMISSION LINE WHILE MAINTAINING THE ENVIRONMENTAL INTEGRITY OF THE NATION FOREST SYSTEM LANDS

FACTUAL BACKGROUND AND REASONS FOR ACTION

The District owns and operates the McKenzie – Beverly 115kV transmission line, which was constructed in the late 1920s in conjunction with the Rock Island Hydro Project. Approximately 20 miles of the transmission line is located within the Okanogan Wenatchee National Forest, where it traverses a rugged section of the Cascade Range.

The District has a continuing obligation to perform line maintenance and replace poles, conductors, and other necessary equipment to maintain reliable operation and service of the line. Re-issuance of the Special Use Permit (SUP) by the United States Department of Agriculture, Forest Service, provides the District with long-term, 30-year, predictable and standard methods of access, operation and maintenance to avoid potential conflicts with other resources or users in the Okanogan Wenatchee National Forest.

Re-issuance of the permit required completion of an Environmental Assessment consistent with the National Environmental Policy Act along with formal consultation and Biological Opinions from the National Oceanic and Atmospheric Administration Marine Fisheries Service and United States Fish and Wildlife Service who consulted on the effects of the Forest Service's issuance of the new SUP for continued maintenance under the proposed operating plan on listed species under the Endangered Species Act. The District will undertake several compensatory mitigation projects that offset the impacts of the transmission line. These projects include decommissioning 8.0 miles of non-system roads on National Forest Lands in the Nason Creek drainage and 1.2 miles of roads on land owned by the Western Rivers Conservancy. In addition, a dispersed campsite will be decommissioned, and the District has authorized riparian restoration in an unused transmission corridor. These mitigation actions address the unavoidable impairment of ecological function caused by continued maintenance of the transmission line and should improve ecological function within the Nason Creek and Wenatchee watersheds consistent with Forest Service's Aquatic Conservation Strategy.

On August 12, 2020 the Forest Service issued a Finding of No Significant Impact based on the site-specific environmental analysis. Subsequently, the Forest Service has offered a Special Use Permit with a 30-year term that incorporates the programmatic operation and maintenance activities that includes standard methods of access. The permit requires the District complete the mitigation actions within 3-5 years of permit issuance and comply with Reasonable and Prudent Measures identified during consultation with the regulatory agencies.

District and Forest Service staff have completed the necessary environmental assessments and reviews and negotiated Special Use Permit, a copy of which is on file in the offices of the District.

Staff recommends the Board of Commissioners authorize the General Manager to execute the permit with the Forest Service.

The General Manager has reviewed staff's recommendation and concurs in the same.

This is proposed as a three-year contract, with two optional one-year renewals, to provide tree trimming along the District's overhead power lines and fiber optical infrastructure. The proposed contract is made up of unit pricing and hourly rate pricing. The tree trimming services help increase service reliability & public safety, along with reducing the risk of fire.

Resolution No. 17-14215 requires Commission approval of bids and authorization to invite bids that are estimated to exceed \$3,000,000. Bidding documents for Bid No. 20-39, including specifications have been prepared by the District and are on file in the offices of the District.

District staff recommends that Bid No. 20-39 is in the best interests of the District and that said documents be approved and that the invitation for bids be published.

A RESOLUTION APPROVING THE PURCHASE AND SALE AGREEMENT WITH CHARLES D. AND JOYCE K. FOLLIS FOR THE SALE OF REAL PROPERTY IN SETTLEMENT OF A PROPERTY DISPUTE AND AUTHORIZING THE GENERAL MANAGER OR HIS DESIGNEE TO COMPLETE THE TRANSACTION

FACTUAL BACKGROUND AND REASONS FOR ACTION

District entered into an Relocation Agreement dated May 13, 1958, with Washington State Highway Commission for relocation of old Primary Highway 10 as part of District's plan to build Rocky Reach Hydroelectric Project, subject to certain terms and conditions including District's filing of a condemnation suit and a decree of public use entered by a court.

District filed a condemnation suit in Chelan County Superior Court, Cause No. 20334 and the court entered an order authorizing the District to inundate those described lands including streets and alleys in the town of Entiat, which included portions of old Primary Highway 10.

District received title to District Property from Washington State by Quit Claim Deed dated February 2nd, 1965, recorded under Chelan County Auditor No. 631729 after Washington State Highway Commission passed Resolution 1084 abandoning Primary Highway 10 and relocated and reestablished pursuant to contract with District.

Pursuant to Ordinance No. 101 on January 27, 1961 City of Entiat approved vacation of Cairns Street, formerly known as a portion of old Primary Highway 10.

However, Entiat did not have the right to vacate old Primary Highway 10 because title was vested in the State of Washington, subject to the 1958 Relocation Agreement and Chelan County Superior Court Order under Cause No. 20334 authorizing District condemnation and inundation of such lands.

Charles D. and Joyce K. Follis ("Purchaser") believed they owned that portion of the old Primary Highway 10 that was vacated by Entiat and which was attached to their property by the Chelan County Assessor's Office by an apparent erroneous application of operation of law ("Disputed Area").

The District and Purchaser, in settlement of any disagreement regarding the Disputed Area have entered in to a Purchase and Sale Agreement dated November 6, 2020, contingent on approval of the Chelan County PUD Board of Commissioners.

The District and Purchaser have entered into a Purchase and Sale Agreement for the Disputed Area in the amount of \$17,330.00, contingent on approval of the Chelan County PUD Board of Commissioners.

Staff recommends approval of the Purchase and Sale Agreement with the Purchaser be approved, and the General Manager directed to take the necessary steps to close the transaction. The General Manager has reviewed staff's recommendation and concurs in the same.
