Public Utility District No. 1 of Chelan County Campground Rules & Regulations Revised on 11/01/2022

Welcome to the parks built and operated by Chelan County PUD. Please review the rules and regulations to ensure an enjoyable and safe visit.

These rules and regulations are intended to assure the public that Public Utility District No. 1 of Chelan County (hereinafter called Chelan PUD) park and recreation facilities are operated and maintained in a clean, attractive and safe condition for the use and enjoyment of all park visitors and are open to all members of the public without discrimination.

These rules and regulations shall apply to Beebe Bridge Park, owned, operated, and maintained by Chelan PUD.

Section 1. Definitions

- 1. **"Registered"** shall mean an individual or group of people that have reserved a campsite online through the PUD website and paid in full. A listing of ALL vehicles that will be at the campsite must be included.
- 2. **"Registered Camper"** is the individual whose name appears on the reservation. To qualify, the individual must be 18 years or older and must occupy campsite every night.
- 3. "Camping" shall mean anyone staying overnight in a Chelan PUD park.
- 4. "Camper(s)" shall mean an individual or a group of people registered and staying overnight in a designated campsite.
- 5. **"Camping Party"** shall mean an individual or a group of people (two or more persons not to exceed eight) that is organized, equipped and capable of sustaining its own camping activity in a single campsite.
- 6. "Overnight" shall mean 10 p.m. 6:30 a.m. also known as Quiet Hours (see Section 3.1).
- 7. **"Camping Season"** shall mean April 15 thru October 15, weather permitting.
- 8. "No Show" is an individual who has made a reservation but neither keeps nor cancels it.
- 9. **"Director"** shall mean the Director of Parks or his/her designee.
- 10. **"Motor Vehicle"** means any self-propelled device via internal combustion engine, electric vehicle, or battery powered vehicle capable of being moved upon a road, and in, upon, or by which any persons or property may be transported or drawn, and includes, but is not limited to, automobiles, trucks, tractors, motorcycles, motor scooters, (jeeps or similar type) four-wheel drive vehicles, and snowmobiles, whether or not they can legally be operated upon the public highways.
- 11. **"Park"** means and includes all Chelan PUD parks and bodies of water contained therein, park drives, parkways, trails, swim beaches, boat launches, athletic fields, play structures, play and recreation grounds or other properties within park boundaries, owned or operated by Chelan PUD and under the management and control of Chelan PUD.
- 12. **"Person"** shall mean all individuals, firms, partnerships, corporations, clubs, and all associations or combinations of persons whenever acting for themselves or by an agent, servant, or employee.
- 13. "Recreation Vehicle (RV)" shall mean a vehicle/trailer unit, van, pickup truck with camper, motor home, converted bus, or any similar type vehicle which contains sleeping and/or housekeeping accommodations.

Section 2. Peace and Quiet

This section is to ensure the public can use the parks without undue disturbance and to ensure neighbors are not unnecessarily disturbed.

1. No person shall conduct themselves so that park users or park employees are disturbed in their sleeping quarters or in campgrounds between the quiet hours of 10 p.m. and 6:30 a.m.

- 2. No person shall use profane or abusive language, or conduct oneself in a disorderly manner on Chelan PUD park property.
- 3. No person shall engage in any activity that has been deemed potentially hazardous to public safety or park property, or incompatible with park property use as designated and posted by Chelan PUD.
- 4. No person shall use a powered public address system, amplified music speaker system, sound-emitting electronic equipment including electrical speakers, radio, phonographs, television, or other such equipment, at a volume which emits sound beyond the immediate individual camp or picnic site that may disturb other park users without written permission of the Director. Portable radios and music players are permitted, provided they shall not be operated at a volume or in any manner that unreasonably disturbs the peace of others.
- 5. People who desire to use loudspeakers, amplified music or public address systems in Chelan PUD parks shall make written application to the Director in advance of the proposed use. The application form may be obtained from the Director.
- 6. Engine-driven electric generators may be operated only between the hours of 8 a.m. and 9 p.m.

Section 3. Camping

Chelan PUD's park and recreation system is designed and administered specifically to provide safe and enjoyable recreation for park visitors. To ensure this occurs, the following park rules apply to campers:

- 1. Chelan PUD campsites are not for residential use.
- 2. Campers and registered vehicles will be limited to ten (10) consecutive nights after which the campers must vacate the park for three (3) consecutive nights. Campers and registered vehicles will be limited to no more than twenty-one (21) days per year.
- 3. Reservations for campsites may be booked:
 - March 1 at 10 a.m.: for April 15 June 15
 - May 3 at 10 a.m.: for June 16 August 15
 - June 1 at 10 a.m.: for August 16 October 15
- 4. To ensure fair and equal opportunity for camping at Beebe Bridge Park a camper must register through the online reservation system. Campsites are available by reservation only.
- 5. If arriving without a reservation, you must complete the reservation process prior to occupying a site.
- 6. The party registering (see Registered Camper, Section 1) for a campsite must occupy it each night. You must be 18 years old to register for a campsite. All members of a camping party regardless of arrival day will vacate on the same day as the original registered camper or sooner.
- 7. All campsites must be reserved through the Chelan PUD reservation system.
- 8. Payment in full is required at the time of booking.

- 9. Cancellations must occur fourteen (14) days prior to the reservation arrival date to be eligible for a refund. Cancellations less than fourteen (14) days before the arrival date will not be eligible for a refund.
- 10. Refunds are not issued for inclement weather, acts of nature or health related issues including Covid-19.
- 11. All campers must be courteous to other campers, park hosts, security, or park personnel.
- 12. All camping must be in areas specifically designated and/or marked for that purpose or as directed by Chelan PUD.
- 13. Check in time is no earlier than 1p.m.
- 14. Checkout time is no later than 11 a.m. Remaining in a campsite beyond the established checkout time may subject the occupant to the payment of a late fee equal to two additional days camping fee and/or suspension of camping privileges for the rest of the year.
- 15. Campers are limited to three (3) campsite reservations during the same time period.
- 16. The number of tents allowed at each campsite shall be limited to the number that will fit on the designated or developed tent pad as determined by Chelan PUD. Tents are not allowed on the grass.
- 17. All campsites must be reserved through the Chelan PUD reservation system. No secondary market purchases allowed.
- 18. Camping reservation will be cancelled if the camping party fails to arrive within twenty-four (24) hours of the original check-in time of 1p.m. (See No Show, definitions)
- 19. Failure to occupy the parties registered site overnight will result in the cancellation of the camping reservation and no refund will be issued. The registered camper must occupy the campsite.
- 20. No person shall take or attempt to take possession of a campsite when it is being occupied by another camping party, or when informed by Chelan PUD that such site is occupied or has been taken out of service by Chelan PUD.
- 21. A maximum of eight (8) people shall be permitted at one campsite, unless otherwise authorized by Chelan PUD.
- 22. Campsites are not guaranteed. We reserve the right to change the site number on the reservation prior to arrival if necessary.
- 23. The number of vehicles occupying a campsite shall be limited to the vehicles that will fit within the designated campsite. No vehicles will be permitted to overhang on grass, tent pad or campground loop road.
- 24. Only one vehicle per campsite shall be permitted to utilize the power outlet. Power splitting is not permitted.

- 25. Registered Campers with a current reservation may park boat trailers in the day use boat launch parking lot during the time of their reservation.
- 26. Violators of Park rules may be asked to leave the park. Once asked to leave the park, the violator(s) will not be allowed to return to the park for the rest of the camping season.
- 27. Battery operated toy vehicles are prohibited in the parking lots, on roads and in the campground.
- 28. All personal items must be removed from the grass and all common areas nightly by 10 p.m.
- 29. For mowing and maintenance purposes, all personal items must be removed from the grass areas on Mondays from 9 a.m. to 12 p.m.
- 30. All fires must be in the designated fire pits. Propane fire pits are not allowed on the grass. No discarding cooking oil, garbage or food.
- 31. The washing of vehicles, boats and RV's is prohibited.
- 32. No person shall possess, discharge, set off, or cause to be discharged, in or into any park area, firecrackers, torpedoes, rockets, fireworks, explosives, or substance harmful to the life or safety of persons or property. This shall also include those devices denominated as "safe and sane" fireworks.
- 33. No cleaning of fish or other food or washing of any clothing or other articles for personal or household use, or any dog or other animal in the restrooms.
- 34. The disposal of carcasses is not allowed. Do not hang carcasses, dump carcasses or gut piles in the campground or any trash receptacles. Please field dress your animal. Dispose of all fish carcasses in deep water.
- 35. Chelan PUD staff, security, and law enforcement has the authority to interpret and enforce all rules.
- 36. Campsite must be left in the same or better condition than found.

Section 4. Pets

- 1. All dogs or other household pets must be kept on a leash no greater than eight (8) feet in length. All pets must always remain in the presence of the owner or handler and under physical restraint while in a Chelan PUD park.
- 2. In any Chelan PUD park, dogs and household pets, except for guide dogs, are not permitted on any designated swimming beach, athletic playing field, children's playground area, or in any public building unless so posted.
- 3. Exotic pets and barnyard animals, including horses, are prohibited in all park areas.
- 4. No person shall allow his dog or other pet or domestic animal to bite, molest, destroy or otherwise annoy or disturb the peace and tranquility of the park or other park visitors.

- 5. Pet owners or handlers are responsible for cleaning up their animal's waste deposits and disposing of the waste in trash receptacles.
- 6. Owners and handlers are required to have in their possession the equipment necessary to remove their animal's waste matter when accompanied by said animal on Chelan PUD park property.
- 7. Pets must not be left unattended in the Parks at any time.
