## Clean hydropower is our go-to fuel

About 92 percent of the electricity supplied by Chelan County PUD is from clean renewable hydropower.

Because we sometimes buy electricity from sources throughout the Pacific Northwest, the state requires Chelan PUD to include a calculated percentage of the source of that purchased power.

Here is the result of those calculations:
